
Please be advised that it has recently come to our attention that our client, the above-referenced homeowners association, has been administratively dissolved for failure to file required forms. We respectfully request that you reinstate the corporation for the following reasons:

1. The corporation had a Belcher Road address listed in your records. This address was for Buxton Properties, a property management company. River Run has not utilized their services since 2000.
2. The form was forwarded to yet another property management company's address. River Run has not worked with this company since April 2002.
3. On November 1, 2002, River Run became aware of their corporation status when the forwarded mail was hand delivered to the Secretary of the Association.
