The undersigned person, having capacity to contract and acting as incorporator of a corporation under the Florida Statutes, Chapter 617 adopts the following Charter for such nonprofit corporation:

**ARTICLE I:**

The name of the corporation is Open Door Church of God & True Holiness Inc.

**ARTICLE II:**

The principal place of business and mailing address of this corporation shall be 1416 Ridge Lake Ct., Lakeland FL 33801.

**ARTICLE III:**

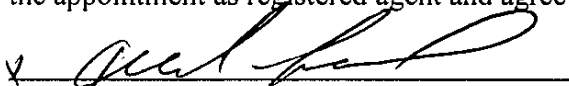

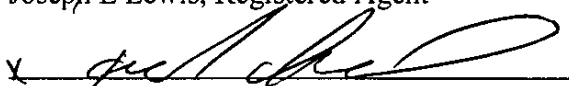
