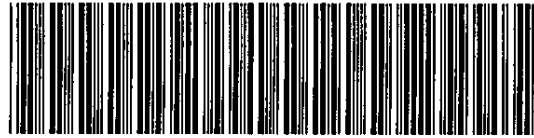

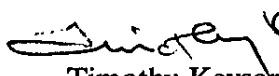

**ARTICLES OF INCORPORATION**

**OF**

**ELIN PARK HOMEOWNERS ASSOCIATION, INC.**

The undersigned, acting as incorporator of a corporation organized under Chapter 617 of the Florida Statutes, adopts the following Articles of Incorporation:

**ARTICLE I – NAME**

The name of this corporation shall be: *ELIN PARK HOMEOWNERS ASSOCIATION, INC.*

**ARTICLE II – PRINCIPAL OFFICE AND MAILING ADDRESS**

The initial principal office of this corporation shall be at 140 East Strickland Road, Interlachen, Florida 32148 and its mailing address is 199 Lee Avenue, Suite 277, Brooklyn, New York 11211.

**ARTICLE III – DURATION AND COMMENCEMENT**

This corporation shall exist perpetually beginning on the 9th day of January, 2007.

**ARTICLE IV – PURPOSES**

The purposes for which this corporation is organized are:

1. To provide for the operation and maintenance of the surface water and stormwater management systems in accord with the laws of Putnam County and the State of Florida; and
2. To hold and own title to land underlying or used for the surface water and stormwater management systems; and.
3. To preserve and protect the appearance of the subdivision for the benefit of all owners within it; and

4. To enforce and implement a declaration of covenants and restrictions for lands within the Elin Park Subdivision , including the levying and collection of adequate assessments from each property owner to pay the cost of the surface water and stormwater management systems; and

5. To perform all other actions necessary and incident to the above purposes.

#### **ARTICLE V – MANNER OF ELECTION OF DIRECTORS**

The number of directors, their methods of election or appointment and their respective duties shall be stated in the bylaws.
