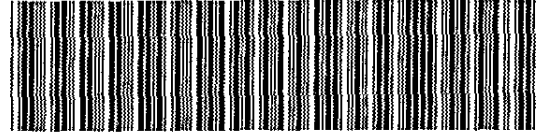

*The undersigned, acting as incorporator(s) of a corporation pursuant to Chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:*

## ARTICLE I - Name

The name of the corporation shall be:

HAITIAN CHURCHES COALITION AGAINST HUNGER & ILLNESS. INC

## ARTICLE II - Principal place of business and mailing address

The principal place of business and the mailing address of this corporation shall be:

## ARTICLE III - Purpose(s)

The specific purpose(s) for which the corporation is organized is (are):

TO PROMOTE AND FURTHER THE RIGHTS AND ASPIRATIONS OF THE HAITIAN-AMERICAN MINORITIES IN DIFFERENT CITIES OF FLORIDA STATE: TO ASSIST MEMBERS OF THE HAITIAN COMMUNITY IN INTEGRATING INTO THE AMERICAN SOCIETY AND ENCOURAGE THEIR FULL PARTICIPATION IN THE SOCIETY; TO FOSTER AND ENCOURAGE THE DEVELOPMENT OF MEMBERS OF THE HAITIAN COMMUNITY CULTURALLY, PHYSICALLY AND SOCIALLY: TO ASSIST THE NEEDY AND THE SICKS THROUGHOUT THE CITIES OF FLORIDA STATE AND THROUGHOUT THE WORLD; FINALLY, TO TO PROVIDE CARE AND VOLUNTEERS TO ASSIST VICTIMS IN TIME OF DISASTER.

## ARTICLE IV - Manner of election of directors

The manner in which the directors are elected or appointed is as follows:

UNDER THE RECOMMENDATION OF THE BOARD OF DIRECTORS THE CANDIDATE SHALL BE SCREENED AND PRESENTED TO THE ASSEMBLY FOR A VOTE, AND THE CANDIDATE SHALL BE ELECTED BY THE MAJORITY OF THE VOTERS, AND HE OR HER SHALL BE AT THE TIME THE ELECTION 18 YEAR OF AGE OR OLDER. THE CANDIDATE SHALL BE ELECTED FOR TWO (2) YEARS AND CAN BE REELECTED BASE ON HIS OR HER DEDICATION, PERFORMANCE AND ABILITY TO SERVE.

## ARTICLE V - Limitation of corporate powers

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes, unless limited as follows: THE CORPORATION IS NOT FORMED FOR PECUNIARY PROFIT OR FINANCIAL GAIN. THEREFORE, NO PARTS OF ITS ASSETS, INCOME OR PROFIT SHALL BE DISTRIBUTED TO OR INSURE TO THE BENEFIT OF ANY PRIVATE INDIVIDUAL. HOWEVER, (next page)




