**SECOND AMENDMENT
TO THE AMENDED AND RESTATED
ARTICLES OF INCORPORATION
OF
CONNECTCITY, INC.**

Pursuant to the provisions of Section 617.1006 of the Florida Statutes, **CONNECTCITY, INC.**, a Florida Not For Profit Corporation (the "Corporation"), adopts the following Second Amendment to its Amended and Restated Articles of Incorporation:


1. The name of the Corporation is **CONNECTCITY, INC.**
2. The original Articles of Incorporation for the Corporation were filed on January 31, 2007, and assigned Charter No. N07000001092, the Amended and Restated Articles of Incorporation for the Corporation were filed on September 11, 2007, and the First Amendment to the Amended and Restated Articles of Incorporation for the Corporation were filed February 29, 2016.
3. By a unanimous written consent executed on July 13, 2017 by the board of directors, the board of directors have approved, authorized, and directed that Article I of the Corporation's Amended and Restated Articles of Incorporation be amended and restated. There are no members entitled to vote on the amendment, and the amendment was adopted by the board of directors.
4. Article I of the Amended and Restated Articles of Incorporation of the Corporation is hereby amended in its entirety to read as follows:

**ARTICLE I -
NAME OF CORPORATION, MAILING ADDRESS
AND ADDRESS OF PRINCIPAL OFFICE**

The name of this Corporation shall be **COMMUNITY RESOURCE NETWORK, INC.** ✓
The mailing address and the principal office address of the Corporation shall be located at 530 Dog Track Road, Longwood, Florida 32750.

IN WITNESS WHEREOF, the President of the Corporation has executed this Second Amendment to Amended and Restated Articles of Incorporation this 13th day of July, 2017, on behalf of the Corporation.
