ARTICLES OF INCORPORATION

OF

CONDOMENSUM ASSOCIATION, INC. A Florida Not for Profit Corporation

STATE OF FLORIDA)
COUNTY OF MIAMI-DADE)

THE UNDERSIGNED hereby make, subscribe, swear, acknowledge and file these Articles of Incorporation for LAKE VUE VILLAS CONDOMINIUM ASSOCIATION, INC.

1. NAM

The name of the corporation shall be LAKE VUE VILLAS CONDOMINION ASSOCIATION, INC., hereinafter referred to as the "Association".

2. PURIPOSE

In accordance with the provisions of Chapter 718, Florida Statutes, the "Condominium Act", a condominium will be created upon certain lands in MIAMI-DADE County, Florida, to be known as LAKE VUB VILLAS, A Condominium (the "Condominium") according to a Declaration of Condominium (the "Declaration") to be recorded in the Public Records of MIAMI-DADE County, Florida. This Association is organized for the purpose of operating, governing, administering and managing the property and affairs of the Condominium and to exercise all powers and discharge all responsibilities granted to it as a corporation under the laws of the State of Florida, the By-Laws and the Act, and to acquire, hold, convey and otherwise deal in and with real and personal property in the Association's capacity as a condominium association.

2. POWERS

The powers of the Association shall include and be governed by the following provisions:

- 3.1 The Association shall have all of the common law and statutory powers of a corporation not-for-profit which are not in conflict with the terms of these Articles and the Declaration, all the powers conferred by the Condominium Act upon a condominium association and all the powers sat forth in the Declaration.
- 3.2 The Association shall have all of the powers reasonably necessary to implement its purpose, including, but not limited to, the following:
- (a) To own and convey property, and without limiting the generality of the foregoing, to operate, maintain, repair, replace, operate and manage the Common Elements specifically including without limitation the surface water management system as permitted by the South Florida Water management District including all lakes, retention areas, culverts and related appurtenances which are located on the Condominium Property (together, the "SWN System");
- (b) To make and collect assessments against Members to defray the cost of the Condominium and to enforce the collection of those assessments:
- (c) To use the proceeds of assessments in the exercise of its powers and duties:
- (d) To reconstruct improvements upon the Condominium Property after casualty and to further improve the property;
 - (m) To make and amend By-Laws, rules and

regulations respecting the use of the Condominium Property and to enforce same;

- (f) To enforce the provisions of the Declaration and these Articles;
- (including contracting for such services) of the Condominium and to authorize a management agent to assist the Association in carrying out its powers and duties by performing such functions as the collection of assessments, preparation of records, enforcement of rules and maintenance of the Common Blements. The Association shall, however, retain at all times the powers and duties granted it by the Condominium Act, including, but not limited to, the making of assessments, promulgation of rules and regulations, and execution of contracts on behalf of the Association;
- (h) To possess, enjoy and exercise all powers nacessary to implement, enforce, and carry into effect the powers above described, including the power to acquire, hold, convey, and deal in real and personal property.

(1) To sue and be sued.

- Association and the proceeds thereof shall be held only for the benefit of the members in accordance with the provisions of the condominium documents. No part of the income, if any, of the Association shall be distributed to the members, directors, and officers of the Association.
- 3.6 The powers of the Association shall be subject to and be exercised in accordance with the provisions of the Declaration which governs the use of the Condominium Property.

4. HENBERS

- 4.1 All Unit Owners in the Condominium shall automatically be members of the Association, and their membership shall automatically terminate when they are no longer Unit Owners. If a member should transfer his Unit pursuant to the provisions of the Declaration, the grantee will automatically be a member of the Association. Membership certificates will not be issued.
- 4.2 Each Unit Owner is entitled to vote its Voting Interest, as defined in and in accordance with the Declaration and in accordance with the By-Laws. An entity or several individuals owning a Unit shall designate one (1) voting member for the Unit(s) which they own, as set forth in the Declaration and By-Laws.
- 4.3 The share of a member in the funds and assets of the Association shall not be assigned, hypothecated, or transferred in any manner except as an appurtenance to the Units.

5. EXISTENCE

The Association shall have perpetual existence. Notwithstanding the foregoing, if for any reason the Association is dissolved, then the last Board of Directors shall convey to the appropriate agency of local government all of the Property constaining of the SWM System together with the right of access to the property containing the SWM System. If such agency does not accept the conveyance, then the SWM System must be dedicated to a similar non-profit corporation.

6. SUBSCRIBER

The name and address of the subscriber hereto is Albert Milo, Jr., 1801 S.W. 3rd Avenue, Suite 500, Miami, Florida 33129.

7. DIRECTORS

- 7.1 The affairs and property of this Association shall be managed and governed by a Board of Directors composed of not less than three (3) nor more than seven (7) pirectors. The first Board of Directors shall have three (3) members, and the number of Directors on subsequent Boards will be determined from time to time in accordance with the provisions of the By-Laws of the Association.
- 7.2 Except for Directors appointed by the Developer in accordance with the Declaration, the Board of Directors shall consist of voting members of the Association. The voting members shall be the individual Unit Owners, except that when multiple individuals, or any corporation, partnership trust or other entity owns a single Unit, a voting member shall be designated for such Unit Owner(s) in accordance with the Ry-Laws of the Association.
- 7.1 Directors shall each serve a one (1) year term, except that a director's term shall end when he or she is no longer a voting member.
- 7.4 All Officers shall be elected by the Board of Directors in accordance with the Sy-Laws at regular, annual meetings of the Board of Directors, to be held as provided in the By-Laws.
- 7.5 The following persons shall constitute the first Board of Directors, and shall hold office and serve in accordance with Article 7.3 herein.

9. BY-LAWS

The By-Laws of the Association shall be adopted by the first Board of Directors and shall be attached to the Declaration to be filed in the public records of MIAMI-DADE County, Florids. The By-Laws may be altered, amended, or rescinded only in the manner provided in the By-Laws.

10. AMENDMENTS

10.1 A majority of the voting members may propose alterations, amendments to, or the rescission of these Articles, so long as the proposals do not conflict with the Condominium Act or the Declaration. Such proposals shall set forth the proposed alteration, amendment, or rescission; shall be in writing, shall be filed by any two members and shall be delivered to the President of the Association, who shall thereupon call a Special Meeting of the members not less than ten (10) days nor later than thirty (30) days from receipt of the proposed amendment, the notice for which shall be given in the manner provided in the By-Laws. An affirmative vote of eighty percent (80%) of the voting members of the Association shall be required for the adoption of the proposed alteration, amendment or rescipsion.

10.2 Any voting member may waive any or all of the requirements of this Article as to notice or proposals to the President of the Association for the alteration, amendment, or rescission of these Articles. Such waiver may occur before, at or after a membership meeting at which a vote is taken to amend, alter or rescind these Articles in whole or in part.

11. INDEMNIFICATION OF OFFICERS AND DIRECTORS

11.1 Every Director and every Officer of the Association shall be indemnified by the Association against all expenses and liability, including counsel fees, reasonably incurred by or imposed upon him in which he may become involved, by reason of his being or having been a Director or Officer at the time such expenses are incurred, except in such cases wherein the Director or Officer is adjudged guilty of willful misfeasance in the performance of his duties; provided that in the event of any claim for reimbursement or indemnification hereunder same shall apply only if the Board of Directors approves such settlement or reimbursement as being in the interests of the Association. Such approval shall be made by a majority vote of a quorum consisting of Directors who were not parties to such proceedings. The foregoing right of indemnification shall be in addition to and not exclusive of all other rights to which such Director or Officer may be entitled.

12. TRANSACTIONS IN WHICH DIRECTORS OR OFFICERS ARE INTERESTED

12.1 No contract or transaction between the Association and one or more of its Directors or Officers, or between the Association and any other corporation, partnership, association, trust or other organization in which one or more of its Directors or Officers are Directors or Officers, or have a financial interest, shall be invalid, void, or voidable solely for this reason, or solely because the Director or Officer is present at or participates in the meeting of the Board or Committee thereof which authorized the contract or transaction, or solely because said Officer's or Director's votes are counted for such purpose. No Director or Officer of the Association shall incur liability by reason of the fact that said Director or Officer may be interested in any such contract or transaction.

12.2 Interested Officers and Directors may be counted in determining the presence of a quorum at a meeting of the Board of Directors or of a committee which authorized the contract or transaction.

13. PRINCIPAL OFFICE

The Association's principal office shall be at 1801 S.w. $3^{\rm rd}$ Avenus, Suite \$00, Miami, Florida 33129.

14. ADDRESS OF REGISTERED OFFICE

The street address of the registered office of this Association in the State of Florida shall be 1801 S.N. 3 Avenue Suite 500, Mizmi, Florida 33129. The name of the initial registered agent shall be Albart Milo, Jr.

15. MRETINGS BY CONFERENCE TELEPHONE

The Board may hold its meetings by means of conference telephone as provided by Section 718.112(2)(b)5, Florida Statutes.
