We, the undersigned, Vito Rallo, and Patricia A. Rallo, being natural persons of the age of twenty-one (21) years or more and citizens of the United States, for the purpose of forming a not for profit corporation under the Florida Department of State, Division of Corporations, do hereby adopt the following Articles of Incorporation, to wit:

ARTICLE I

The name of the corporation shall be: Free Indeed Ministries of Tampa Bay, Inc.

ARTICLE II

The principal place of business of the corporation's initial registered office in the state of Florida is:

ARTICLE III

The purpose or purposes for which the corporation is organized are:

- (a) The corporation is organized for religious purposes.
- (b) The corporation is formed to promulgate the teachings of the Holy Bible and to spread this word.
- (c) The corporation is formed to provide exclusively religious, charitable and educational purposes within the meaning of Section 501 (c) (3), Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).

- (d) To establish a center for development and training of people for religious purposes.
- (e) To provide personnel to work in prison ministry within the State of Florida.
- (f) To participate in radio and television ministry where possible.
- (g) To provide Biblical teaching and counseling.
- (h) To provide charitable acts of service to those in need.

ARTICLE IV

Directors are to be chosen and appointed by the mutual agreement and consent of the founders of the corporation. The first Board of Directors shall be four (4) in number and their names and addresses are as follows under Article V.

ARTICLE VIII

The effective date of the corporation shall be March 20, 2007.

ARTICLE IX

No part of the net earnings of the corporation shall inure for the benefit of, or be distributed to, its trustees, officers, or other private persons except that the

corporation shall be authorized and in power to pay reasonable compensations for services rendered.

ARTICLE X

Upon the dissolution of the corporation, the Board of Directors shall, after paying or making provisions for the payment of all of the liabilities of the corporation, dispose of all of the assets of the corporation exclusively for the purposes of the corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational and religious purposes as shall at that time qualify as an exempt organization or organizations under Section 501 (c) (3), Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law), as the Board of Directors shall determine. Any such asset not so disposed of by the Directors shall be disposed of by the Circuit Court of the county in which the principal office of the corporation is then located, exclusively for such purpose of purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes mentioned hereto before.
