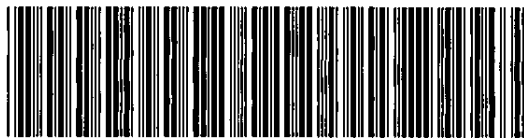

Article I - Name

The name of the organization shall be
FAMU High Developmental Research School (~~DRS~~) Base Organization/Reunion, Inc.

Article II - Principal Place of Business

The principal place of business and mailing address of the corporation shall be

ARTICLE II - GOVERNING AUTHORITY

The Bylaws of FAMU High ^{School} ~~DRS~~ Base Organization/Reunion, Inc. shall govern the organization in all of its practices. Every Article and amendment to the Constitution and By-Laws shall become effective immediately upon adoption and shall be binding on all members of FAMU High ~~DRS~~ Base Organization/Reunion, Inc.

Article III - Purpose

The purpose of the corporation is to provide resources to ^{School} enrich the educational and social environment of the Florida A and M University High ~~DRS~~. To unite as one body with a common goal of fellowship and service in preserving the FAMU High School ~~DRS~~ Legacy.

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (C) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

Article IV - Membership

Membership shall be composed of interested individuals who are graduates, attendees or past or present faculty and staff of FAMU High ~~DRS~~ ^{School}. Voting members are those members whose dues are current on an annual basis.

Article V – Manner of Election

The manner in which the officers are appointed or elected is by a two-thirds majority vote of members present and voting at organizational meetings assembled for a purpose of election as provided for in the By-Laws.

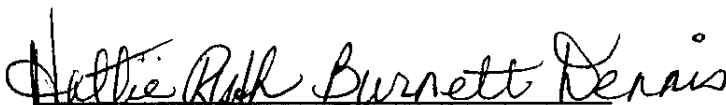

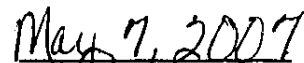
