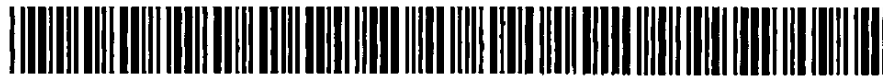

ARTICLES OF INCORPORATION
OF

The undersigned, for the purpose of forming a not for profit corporation under Chapter 617, Florida Statutes, does hereby adopt the following Articles of Incorporation:

ARTICLE I: NAME

The name of the corporation is **FLORIDA NEW FEDERATION OF REPUBLICAN WOMEN INCORPORATED**

ARTICLE II: PRINCIPAL OFFICE

The principal place of business and mailing address of the corporation is 4911 NE 27th Terrace, Lighthouse Point, FL 33064.

ARTICLE III: PURPOSE

The purpose of this non profit corporation is a political group designed to further candidates and causes.

ARTICLE IV: QUALIFICATION

The qualifications for members and the manner of their admission are stated in the bylaws of the corporation.

ARTICLE V: INITIAL REGISTERED OFFICE AND AGENT

ARTICLE VI: INITIAL BOARD OF DIRECTORS

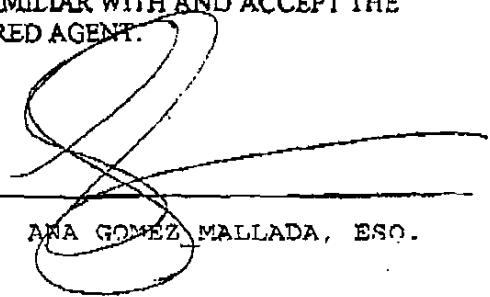
