Pursuant to the provisions of Section 617.1006, Florida Statutes, this Florida Not-for Profit Corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the Corporation is NEW SUN FOUNDATION, INC. (hereinafter called the "Corporation") (Document Number N07000006102).
2. Article 1 of the Corporation's Articles of Incorporation is hereby amended as follows:

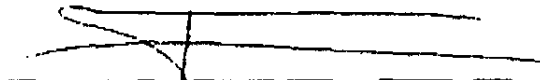
"ARTICLE I
