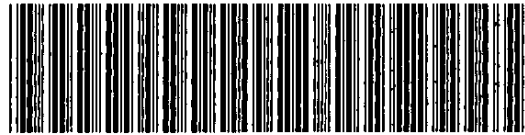

This non-denominational church began in April of 2007 when the founder, Pastor Gertrude Garciga began a prayer meeting in the living room of her house. The prayer meeting traveled from her house to Chattahoochee, Florida to a chapel there. Upon the divine guidance and direction of God, a prayer band was established in the Sinai Community of Sneads, Florida. On Sunday, June 10, 2007 by revelation, Pastor Garciga received a name for the ministry. The name is based on two passages of scripture: Leviticus 20:7 and Saint Matthew 16:17-18. The Sinai Community is an area where such a ministry is needed to both change and impact individuals in a positive manner. The church is a Bible-based ministry designed to both reach and save souls for the Kingdom.

#### **Article IV: The Manner of Election of Directors**

The directors will be elected on the 1<sup>st</sup> Sunday of each January. The church body will submit names during a general meeting and then vote on those who will serve the church for the entire year. After election the members of the board will act on behalf of the congregation and in the best interest of the body. These board members will provide periodic reports to the general membership on the performance of the church's programs including its financial positioning. Upon the vacancy or misfeasance or malfeasance of duties, the Pastor may appoint a person(s) to fill the position for the remainder of the year or until an election is held by the church.
