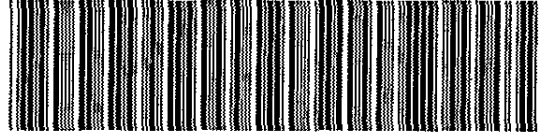

ARTICLE I NAME

The name of the corporation shall be Christ's Church Homeschoolers, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business of this corporation shall be Christ's Church Mandarin, 6045 Greenland Road, Jacksonville, FL, 32258.

The mailing address of this corporation shall be 12456 Macaw Drive, Jacksonville, FL, 32223.

ARTICLE III PURPOSE

The purpose for which the corporation is organized is to encourage and support families who have chosen to educate their children at home. This is accomplished through classes, field trips, and other educational and social activities.

ARTICLE IV MANNER OF ELECTION

A Board of Directors shall be appointed among those members who attend Christ's Church. Board members shall be appointed and approved on an annual basis.

ARTICLE VIII TAX EXEMPT PROVISIONS

Upon the dissolution of Christ's Church Homeschoolers, Inc., assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for public purpose.

Christ's Church Homeschoolers, Inc. is organized exclusively for charitable, religious, education, and/or scientific purposes under section 501(c)(3) of the Internal Revenue Code. No part of the net earnings of Christ's Church Homeschoolers, Inc. shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof.

No substantial part of the activities of Christ's Church Homeschoolers, Inc. shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Having been named as registered agent to accept service of process for the above stated corporation at the place designated in this certificate, I am familiar with and accept the appointment as registered agent and agree to act in this capacity.
