

I, Philip P. Kurtz, acting in my capacity as incorporator and managing director of PROFESSIONAL COUNSELING CENTERS OF GREATER JACKSONVILLE AND ORANGE PARK, INC., advise that I am voluntarily dissolving the entity, retroactive to its date of inception, i.e., 07/31/2007.


This letter accompanies the Articles of Dissolution (attached).

Dissolution to the date of inception has become necessary as a result of recent discussions with the IRS in which I first became aware that the entity was never registered as a 501(c)(3) organization, contrary to my belief and understanding. Upon registering the entity with the FL Department of State, I paid an attorney to complete the IRC 501(c)(3) registration. I have just become aware that the attorney failed to complete or even begin that registration despite having been paid to do so. The IRS has advised me that it will be necessary effectively to "un-do" the entity from Day 1 to resolve all federal tax matters connected with this entity.

I am in the process of filing amended federal and state payroll reports to straighten out the payroll liabilities and payments that have been inadvertently misreported due to these problems.
