Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c) (3) of the Internal Revenue Code. 22 DEGREES MOTORCYCLE CLUB shall distribute any remaining assets to similar non-profit organizations to assist them in meeting similar goals. And/Or, any remaining assets will be donated to other charitable organizations benefiting children, homeless or the disabled.
