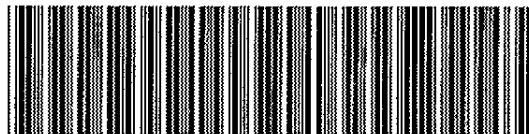

ARTICLE OF INCORPORATION
OF
ADENIJI FOUNDATION, INC.
A FLORIDA NON-PROFIT CORPORATION

(Pursuant to Chapter 617, Florida Statutes.)

The undersigned has, for the purpose of forming a non-profit corporation under the laws of Florida, adopted the following Articles of Incorporation.

ARTICLE I NAME

The name of the corporation shall be:
ADENIJI FOUNDATION, INC

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

ARTICLE III PURPOSE

The purposes for which for which this corporation is organized include:

- Promote finding a cure for Sickle Cell disease
- Improving the quality of life for individuals and families where Sickle Cell related conditions exist
- Provide a means of free medication for patients in crises
- Collaborate with existing Sickle Cell organizations in the United States and beyond
- Assist in fundraising campaigns for the various chapters of the Sickle Cell Association in the United States and beyond
- Occasional visitation to children with Sickle Cell disease accompanied with gifts.

- Organize concerts, talks and other events with the purpose of raising funds and educating the public on the prevention of Sickle Cell disease.

Adeniji Foundation, Inc. is organized exclusively *for Charitable, educational and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organization under section 501(c) (3) of internal revenue code, or corresponding section of any future federal tax code.*

ARTICLE IV

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, Trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purpose set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on

- a. By an organization exempt from federal income tax under section 501(c)(3) of the internal Revenue code, or corresponding section of any future federal tax code.
- b. By an organization, contributions to which are deductible under section 170(c)(2) of the internal Revenue code, or corresponding section of any future federal tax code

ARTICLE V MANNER OF ELECTION

The manner in which the directors are elected or appointed is as stated in the bylaws.
