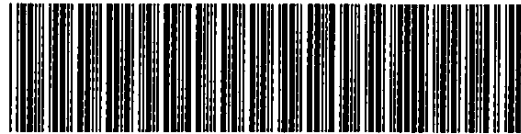

ARTICLES OF INCORPORATION**

ARTICLE I

NAME OF THE CORPORATION

The name of this corporation is: Tanglewood Community Church, Inc.

ARTICLE II

PRINCIPAL OFFICE

ARTICLE III

PURPOSE

The purpose of this congregation shall be to proclaim and propagate the Christian Faith through means of grace.

ARTICLE IV

MANNER OF ELECTION

1. Members of this congregation shall consist of all of who request to be members for the true purpose of this institution is that the people will hear and receive the true knowledge of the Word of God.
2. Voting members of this congregation are those members who attend the monthly meetings which are held on the second Wednesday of each month. All elections are decided by a simple majority of those votes cast.
3. During the December monthly meeting, elections will be held for the church officers which consist of: Chairman, one or two Co-Chairman, Secretary, and Treasurer. These officers constitute the Church Board which is the governing body of the Tanglewood Community Church, Inc.
4. Officers are elected for a term of two years and are limited to a total of two consecutive terms. They will be eligible for the same office after an absence of two years. However, they may stand for election for a different office. In event of a vacancy during the term of office on the Church Board, the Board will pick a replacement by a majority vote of the remaining Board members. This new member of the Board will only complete the term of the replaced member; but could then stand for election and fall under the same term restrictions as other Board members.

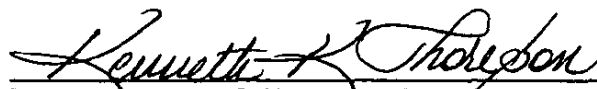

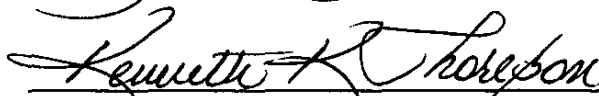
