## AMENDMENT ADOPTED:

ARTICLE VIII: DISSOLUTION

The Eau Gallie Area Service Council, Inc. may be dissolved with the assent given in writing and signed by members entitled to cast two-thirds of the votes of the entire membership. Upon dissolution of the Council, the assets, both real and personal of the Council, shall be dedicated to an appropriate public agency to be devoted to purposes as nearly as practicable the same as those to which they were required to be devoted by the Council. In the event that such dedication is refused acceptance, such assets shall be granted, conveyed and assigned to any non-profit corporation, association, trust or other organization to be devoted to purposes and uses that would most nearly reflect the purposes and uses to which they were required to be devoted by the Eau Gallie Area Service Council, Inc.
