Pursuant to the provisions of Section 617.1006 of the Florida Statutes, this Florida Not For Profit Corporation adopts the following amendment(s) to its Articles of Incorporation:

1. The current name of the corporation is **THE JON & LORI ZEPF FOUNDATION, INC.**
2. The original Articles of Incorporation for the corporation were filed on October 2, 2007, and assigned Document No. N07000009686.
3. The Articles of Incorporation are hereby amended to read as follows:

Article I of the Articles of Incorporation is hereby amended by deleting said Article as it presently exists and substituting the following in its place for all purposes:]-

**ARTICLE I.  
NAME**

The name of the Corporation shall be **THE JON S. & LORI ZEPF FOUNDATION, INC.**
