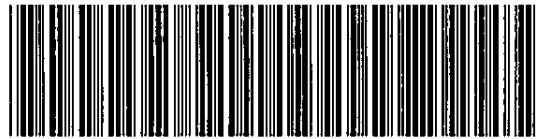

Pursuant to the provisions of section 617.1006, Florida Statutes, in this **Florida Not For Profit Corporation (Church)** adopts the following amendment (s) to its Articles of Incorporation.

**ARTICLE III – PURPOSE OF CORPORATION
NON FOR PROFIT (CHURCH)**

The Corporation is organized exclusively for charitable, religious, educational and scientific purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c) (03) of the Internal Revenue Code or the corresponding section of any future federal tax code.

ARTICLE III – PROHIBITIONS

No part of the net earnings of the Corporation shall inure to the benefit of or be distributable to its members, trustees, officers or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Articles Second hereof. No substantial part of the activities of the Corporation shall be carrying on of propaganda, or otherwise attempting to influence legislation and the Corporation shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate

for public office. Notwithstanding any other provision of these articles, the Corporation shall not carry on any other activities nor permitted to be carried on (a) by a Corporation exempt from federal income tax under section 501(c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a Corporation, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

In the event of dissolution of the Non For Profit Corporation (Church), any and all assets acquired, will be distributed to any Non For Profit Corporation (Church) Non For Profit Organization as permitted under section 501 (c) (03) of the Internal Revenue Code.

ARTICLE VII – OFFICERS

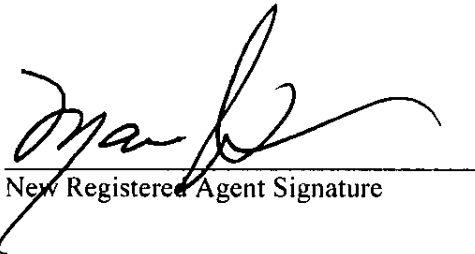
