- 1. The Association was originally incorporated on November 1, 2007, Document Number N07000010681, under Chapter 617 of the laws of the State of Florida.
- 2. The Declaration of Condominium of La Casetta, a Condominium, was recorded on June 30, 2008, in Official Records Book 18725, Pages 122 through 218, of the Public Records of Hillsborough County, Florida.
