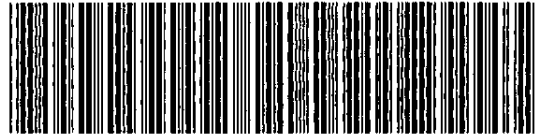

Article VIII

a.
