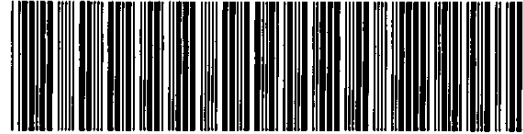

ARTICLE I - Name

The name of the corporation shall be:

ARTICLE II - Principal place of business and mailing address

ARTICLE III - Purpose(s)

The specific purposes for which the corporation is organized are:

4. To provide humanitarian assistance, such as food and/or clothes to the elderly, homeless and needy in our community regardless of their beliefs.

ARTICLE IV - Manner of election of directors.

The method of election of directors shall be stated in the bylaws of this corporation.

ARTICLE V - Limitation of corporate powers

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes, unless limited as follows:

ARMADURA DE DIOS, INC., is to have the power to do any and all things necessary or expedient for carrying out the purposes of this corporation, and in general to possess all rights, privileges and immunities, and to enjoy all the benefits granted to corporations of similar characters under the laws of the State of Florida. These powers shall include, but not be limited to:

1. Erect, purchase, enter into a lease agreement, and maintain and upgrade, business offices, and such other structures deemed necessary to carry out the overall purposes of this corporation.
2. Collect, solicit, and accept funds, gifts, and other subscriptions necessary to purchase, lease and maintain all facilities used for the stated purposes of this corporation as a nonprofit organization.
3. Conduct Bible studies, perform evangelistic religious services as well as any other religious activities and programs of Christian nature admissible by law.
4. Conduct all other powers necessary to carry out the general and specific purposes of the corporation.






