

ARTICLES OF INCORPORATION
of
COMMUNITY COMPACT, INC.

- FIRST:** The name of this Corporation is COMMUNITY COMPACT, INC.
- SECOND:** This Corporation is organized for the purpose of transacting any and all lawful business for which corporations may be formed under Chapter 617 of the Florida Statutes.

This Corporation is organized exclusively for one or more purposes as specified in Section 501(c)(3) of the Internal Revenue Code or the corresponding section of any future federal tax code including for such purposes the making of distributions to organizations that qualify as exempt in organizations under 501 (c) (3) of the Internal Revenue Code, of the corresponding section of any future tax code.

No substantial part of the Corporation's activities shall consist of carrying on propaganda, or otherwise attempting to influence legislation (except in accordance with Section 501 (h) of the Internal Revenue Code or corresponding section of any future tax code). The Corporation shall not participate in any political campaign on behalf of or opposition to any candidate for political office.

Upon the dissolution of the organization, the organization's assets shall be distributed for one or more exempt purposes within the meaning of Section 501 (c) 3) of the Internal Revenue Code, or corresponding section of any future federal tax, or shall be distributed to the federal government or to a state of local government for a public purpose.

- THIRD:** The Corporation's principal place of business is 1555 Palm Beach Lakes Boulevard, Suite 1220, West Palm Beach, Florida 33401 and the Corporation's mailing address is c/o Mary C. Arpe, Esquire, Gelfand & Arpe, P.A., 1555 Palm Beach Lakes Boulevard, Suite 1220, West Palm Beach, Florida 33401.
- FOURTH:** The street address of the initial registered office of this Corporation is 1555 Palm Beach Lakes Boulevard, Suite 1220, West Palm Beach, Florida 33401 and the name of the initial registered agent of this Corporation at that address is Mary C. Arpe.
- FIFTH:** The manner in which the directors are elected or appointed shall be set forth in the bylaws. This Corporation shall have three directors initially and the number of directors may be increased or diminished from time to time as provided in the Bylaws but shall never be less than three.


