## ARTIČLES OF INCORPORATION OF PHILIPPINE ASSOCIATION OF MEDICAL TECHNOLOGISTS (PAMET-USA) FLORIDA CHAPTER, INCORPORATED

A Florida Not for Profit Corporation

The undersigned incorporators, under Chapter 617, Laws of the State of Florida, providing for the formation, liability, rights, privileges and immunities of a Not for Profit Corporation, adopts the following articles of incorporation.

#### ARTICLE I. NAME

The name of this corporation is Philippine Association of Medical Technologists (PAMET-USA) Florida Chapter, Incorporated.

#### ARTICLE II. STATEMENT OF CORPORATE NATURE

This is a nonprofit corporation organized solely for general educational purposes pursuant to the Florida Not for Profit Corporation Act set forth in Part I of Chapter 617 of the Florida Statutes.

#### **ARTICLE III. PURPOSES**

The primary purposes for which this corporation is formed are to unite Filipino medical technologists that maintain their common welfare and interest. Secure recognition and enjoyment of the rights and privileges to which we are justly entitled to, as medical technologists

To provide assistance to Filipino medical technologists in preparation for their professional certification and to promote continuing education to enhance our professional growth and development.

#### ARTICLE IV. DEDICATION OF ASSETS

The property of this corporation is irrevocably dedicated to educational and or charitable purposes and in no part of the net asset of this corporation shall ever enure to the benefit officer or member thereof.

#### ARTICLE V. MEMBERSHIP

Membership is open to anybody of Filipino ancestry, who has a medical technology degree from the Philippines or the USA, who resides in the United States and/or working in a medical laboratory and who is supportive of promoting its professional and cultural well-being.

Active member is defined as a member with good moral character, one who has paid his/her annual membership dues and has participated in at least one (1) chapter activity.

Active member in good standing is defined as a member with good moral character, paid his/her annual membership dues and who have participated in at least two (2) PAMET chapter projects every two years. Said member is entitled to hold office and serve on the Board and Committees.

**Associate member** is defined as a non-Filipino medical technologist working in a medical laboratory or related sciences and who is supportive of the organization's objectives. They are not entitled to vote or hold office.

**Membership dues:** Annual membership dues shall be thirty dollars (\$30.00) and seventy five dollars (\$75.00) for three (3) years. Annual dues for Associate member is twenty five dollars (\$25.00). All dues are payable upon submission of application for membership. Annual national dues of five dollars (\$5.00) is included in the above dues.

After initial membership dues are paid, annual dues shall be paid on or before January 1 of each year thereafter. Any membership dues paid by October 31, of the current year, he/she will be covered until December 31 of the following year.

#### ARTICLE VI. ELECTION OF BOARD OF DIRECTORS

The board of directors shall be elected in accordance with methods and qualifications specified in the bylaws of the Corporation. In no event, shall the number of directors be fewer than three.

### ARTICLE VII: NAME AND MAILING ADDRESS OF INITIAL REGISTERED AGENT.

#### **ARTICLE VIII: DISSOLUTION**

Upon the dissolution of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation, shall be distributed to a foundation or corporation organized and operated exclusively for educational or charitable purposes which has established its tax exempt status under Section 501 (c) (3) of the Internal Revenue Code or corresponding provisions of any subsequent federal tax laws.

Amendments to these articles of incorporation may be proposed by a resolution adopted by the Board of Directors and presented to the members for their vote, no later than ninety (90) days prior to the next general membership meeting. The membership body may submit to the committee any proposed amendments they have, fifteen (15) days prior to general membership meeting.
