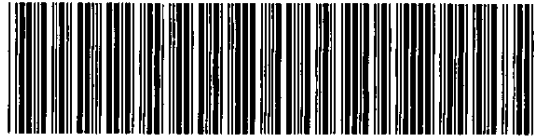

UNION NO. 100 HOLDING CORPORATION**

The undersigned, acting as incorporator of a corporation not-for-profit pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation

ARTICLE I: NAME

The Corporation shall be named Government Supervisors Association of Florida, OPEIU, Local Union No. 100 Holding Corporation.

ARTICLE II: PRINCIPAL OFFICE AND MAILING ADDRESS

The principal office and the mailing address of the Government Supervisors Association of Florida, OPEIU, Local Union No. 100 Holding Corporation are:

Miramar, FL 33025

ARTICLE III: PURPOSES

- 3.1 To hold title to real property, as permitted by 26 U.S.C. §501(c)(2), on behalf of Government Supervisors Association of Florida, OPEIU, Local Union No. 100, a tax exempt employee organization under Florida Statutes, Chapter 447, Part II and a labor organization under 26 U.S.C. 501(c)(5).
- 3.2 To promote all other non-profit purposes that are consistent with Chapter 617, Florida Statutes.

ARTICLE IV: DIRECTORS

- 4.1 There shall be 3 Directors, who shall be appointed in the manner specified in the bylaws of the Government Supervisors Association of Florida, OPEIU, Local Union No. 100 Holding Corporation.
- 4.2 The term of each Director shall be coterminous with that of his office in Government Supervisors Association of Florida, OPEIU, Local Union No. 100. The number of Directors shall not be fewer than three. Should any of the above-designated officers of Government Supervisors Association of Florida, OPEIU, Local Union No. 100 be unwilling or unable to serve as Director of the Government Supervisors Association of Florida, OPEIU, Local Union No. 100 Holding Corporation, he shall so state in writing, in a form acceptable by the remaining Directors, and the remaining Directors shall appoint from among the membership of Government Supervisors Association of Florida, OPEIU, Local Union No. 100, a Director in that officer's place, in accordance with

vacancy procedures of §617.0809, Florida Statutes. The Director so appointed shall hold the office that the person for whom he substitutes would have held.

- 4.3 Should any vacancy of an office of Government Supervisors Association of Florida, OPEIU, Local Union No. 100 persist beyond (45) days, the Directors of the Government Supervisors Association of Florida, OPEIU, Local Union No. 100 Holding Corporation shall appoint from among the membership of Government Supervisors Association of Florida, OPEIU, Local Union No. 100, a Director to fill any consequent vacancy on the Board of Directors, in accordance with the vacancy procedures of §617.0809, Florida Statutes. The Director so appointed shall serve until such time as the vacant office of Government Supervisors Association of Florida, OPEIU, Local Union No. 100 is filled, and shall hold the office that corresponds to the vacancy in Government Supervisors Association of Florida, OPEIU, Local Union No. 100.
- 4.4 The Board of Directors may establish by-laws, records, notices, and/or any other corporate documents as they deem appropriate, and as are necessary by law.

ARTICLE V: CORPORATE OFFICERS

- 5.1 The President of Government Supervisors Association of Florida, OPEIU, Local Union No. 100 shall serve as President of the Government Supervisors Association of Florida, OPEIU, Local Union No. 100 Holding Corporation; the First Vice President of Government Supervisors Association of Florida, OPEIU, Local Union No. 100 shall serve as the Vice-President of the Government Supervisors Association of Florida, OPEIU, Local Union No. 100 Holding Corporation; the Treasurer of Government Supervisors Association of Florida, OPEIU, Local Union No. 100 shall serve as the Secretary-Treasurer of the Government Supervisors Association of Florida, OPEIU, Local Union No. 100 Holding Corporation.

ARTICLE VI: CORPORATE POWERS

- 6.1 The Government Supervisors Association of Florida, OPEIU, Local Union No. 100 Holding Corporation shall not exercise any powers inconsistent with the provisions of §617.0302, Florida Statutes or 26 U.S.C. 501(c)(2).
- 6.2 No article, by-law, or corporate document shall limit or be interpreted to limit the powers of the Government Supervisors Association of Florida, OPEIU, Local Union No. 100 Holding Corporation that are authorized by Chapter 617, Florida Statutes.
