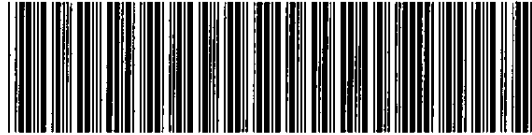

**ARTICLE I NAME**

The name of the corporation shall be:

Certified Travel Professionals, Inc.

**ARTICLE II PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be:

**ARTICLE III PURPOSE**

The purpose for which the corporation is organized is:

Said organization is organized for providing financial assistance, educational, support and charitable bequest for the travel industry and to preserving the general welfare and to qualify under section 501 (c) of the Internal Revenue code or corresponding section of any future tax code.

No part of the net earnings of the organization shall inure to the benefit, or be distributed to its members, officers or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purposes clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) in any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501 (c) (3) of the Internal Revenue code or corresponding action of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170 (e) (2) of the Internal Revenue code or corresponding section of any future federal tax code.

Upon dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue code or shall be distributed to the federal government, or to a state or local government for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization(s), as said Court shall determine, which are organized and operated for such purpose.

**ARTICLE IV MANNER OF ELECTION**

Directors are elected in accordance with the organization's bylaws. Directors will be elected each year at the Annual Meeting.




