**ARTICLES OF AMENDMENT  
TO THE ARTICLES OF INCORPORATION  
OF  
MADAGASCAR FOUNDATION, INC.**

The undersigned President of Madagascar Foundation, Inc., a Florida Not for Profit Corporation (the "Corporation"), incorporated on March 25, 2008, under document number N08000002946, pursuant to the Florida Not For Profit Corporation Act, Chapter 617, Florida Statutes, hereby certifies as follows:

1. The name of the Corporation is MADAGASCAR FOUNDATION, INC.
2. The principal place of business is 201 S. Biscayne Blvd., 15<sup>th</sup> Floor, Miami, Florida 33131
3. Article I of the Articles of Incorporation of the Corporation is hereby amended to change the name of the Corporation to "AKBARALY FOUNDATION, INC." Accordingly, Article I of the Articles of Incorporation shall read in its entirety as follows:

**ARTICLE I**

The name of the Corporation shall be AKBARALY FOUNDATION, INC.

4. Except as above amended, the Articles of Incorporation of the Corporation, as filed with the Florida Department of State, shall remain in full force and effect.
5. The Corporation has no members and the foregoing amendment was duly adopted as of August 2, 2010, by written consent of the Board of Directors of the Corporation.
