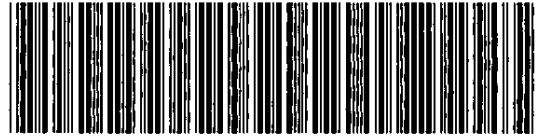



**Articles of Incorporation
of
Mercy Drive Ministries, Inc.**

Article One: The name of the corporation shall be: Mercy Drive Ministries, Inc., hereafter referred to as the "Corporation."

Article Two: The Corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. The Corporation is organized under the Florida Not For Profit Corporation Act as set forth in Chapter 617 of the Florida Statutes. The specific purpose of the Corporation is to initiate and support inner-city projects, including, but not limited to, health services, counseling services, employment and community development.

Article Three: The Corporation shall have no members.

Article Four: The address and the principal office of the Corporation is 1531 Mercy Drive, Orlando, Florida 32808

Article Five: a) The Corporation is organized and operated exclusively for charitable purposes as outlined in Section 501(c)(3) of the Internal Revenue Code.

b) Notwithstanding any other provision of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.

c) No substantial part of the activities of the Corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of any candidate for political office.

Article Six: The Corporation shall be managed by a Board of Directors which shall consist of not less than five (5) and not more than ten (11) directors. Each director shall be at least eighteen (18) years of age. The first Board of Directors shall consist of the persons named in these Articles, and they shall hold office until their successors have been duly elected and qualified. New Board Members shall be appointed as stated in Article V. Section 3. of the By-Laws of the Corporation. The initial Board of Directors are appointed as stated in the by-laws.

Article Eight: The name and address of the designated Agent for Service of Process shall be William Andrews 2323 South Westmoreland Drive, Orlando Florida 32805



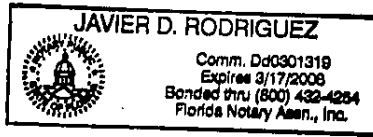
