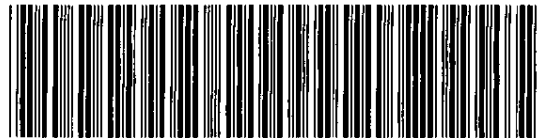

ARTICLES OF INCORPORATION

At a meeting of the Board of Directors, the following Amended Articles of Incorporation were authorized and adopted:

Article I (Name)

The name of the organization shall be:
Mighty Wings of Glory Camps Ministries, Inc.

Article II (Office/Mailing Address)

The corporation's registered office in the State of Florida is as follows:
710 NW 16th Avenue, Apt. 21
Gainesville, FL 32601

The corporation's mailing address in the State of Florida is as follows:

Article III (Purposes)

The general nature and purpose of this corporation is to exact the name of Jesus Christ through worship, to edify through fellowship, to evangelize by proclaiming the true Word of God. We will serve as a non-profit religious institution resolving the following principles relative to biblical holiness: Whereas, the Mighty Wings of Glory Camps Ministries, Inc., historically a Bible-believing church; and whereas, we are enjoined by the scriptures to be so; and whereas, a tide of worldliness threatens the spirituality of the church, be it resolved that we, the Mighty Wings of Glory Camps Ministries, Inc. reaffirm our standard of holiness, in stated doctrine, in principles of conduct and as a living reality in our hearts. Be it further resolved that we, as ministers and members, rededicate ourselves to this purpose and guard our lives against conformity to the world in appearance, in selfish ambition, in carnal attitudes, and in evil associations. Be it further resolved that we, and ministers and members, seek to conform to the positive virtues of love, mercy, and forgiveness as taught by Jesus Christ.

This corporation is organized exclusively for charitable, educational, religious or scientific purposes within the meaning of Section 501(c)(3) or the Internal Revenue Code (or corresponding section of any future federal tax codes).

This corporation is organized and operated exclusively for non-profit purposes, and no part of any net earnings shall inure to the benefit of any member, director or officer.

Notwithstanding any other provision of the Articles, the corporation shall not carry on any other activities not permitted to be carried on a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code (or corresponding section of any future federal tax codes), or b) by a corporation to which contributions are deductible under Section 170(c)(2) of the Internal Revenue Code (or corresponding section of any future federal tax codes).

Article IV (Election of Directors)

The powers of this corporation shall be exercised, its properties controlled, and its affairs conducted by a board of four (4) to seven (7) Directors as determined by the unincorporated body of Mighty Wings of Glory Camps Ministries, Inc., as specified in its Constitution and By-laws.

Directors shall be elected in accordance with the Constitution and By-laws.

Article V (Officers of Corporate Affairs)

ARTICLE VIII (Fiscal Year)

The fiscal year of the corporation will begin January 1st of each year, and end December 31st of each year.

Article IX (Term)

The term for which this corporation shall exist shall be perpetual.

Article X (Membership)

The qualification of members of this corporation shall be that they each are member in good standing of, and in the unincorporated body of, Mighty Wings of Glory Camps Ministries, Inc.

New members of this corporation shall be admitted only through membership in said unincorporated body as specified in the Constitution and By-laws. Membership in this corporation, and in said unincorporated body, shall be identical. Membership rights and privileges are specified in the Constitution and By-laws.

Article XI (Enabling Law)

The general nature of this religious establishment is to be transacted by this corporation and the purpose for which it is organized is to own, purchase, hold, manage, lease, mortgage, pledge and otherwise handle and dispose of such real estate and personal property as shall be authorized and directed by the unincorporated body of Mighty Wings of Glory Camps Ministries church, Gainesville, Florida, hereinafter known as said body; and to do any and all other business, acts, and things as may be allowed under the laws of Florida and authorized by said body according to the Constitution and By-laws of the unincorporated body.

Article XII (By-laws)

The Constitution and By-laws of this corporation shall be identical and the same as the Constitution and By-laws made, amended, altered and rescinded by the members in good standing of said unincorporated body. Any amendments to the Constitution and By-laws shall be binding on all members of this corporation.

All officers, directors, and agents of this corporation shall be elected, recalled, replaced, instructed and controlled in any business or matter relating to the affairs of this corporation in accordance with the terms of the Constitution and By-laws of the unincorporated body of Mighty Wings of Glory Camps Ministries, Inc.

It is required that the unincorporated body mentioned in this charter shall believe in and subscribe to the Articles of Faith and the Article of Doctrine as prescribed in the Constitution of said body. The unincorporated body mentioned in this charter shall subscribe to the faith and doctrine of the Mighty Wings of Glory Camps Ministries, Inc.

Article XIII (Activities)

No substantial part of the activities of the organization shall be carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by 501(c) or participating in, or intervening in (including the publication or distribution of statements), any political campaign on behalf of or in opposition to any candidates for public office.

Article XIV (Earnings)

No part of the net earnings of the organization shall inure to the benefit of any member, trustee, director, officer of the organization, or any private individual (except that reasonable compensation may be paid for services rendered to or for the organization), and no member, trustee, officer of the organization or any private individual shall be entitled to share in the distribution of any of the organization.

Article XV (Amendments of Articles)

Amendments to these Articles of Incorporation may be proposed and adopted by members in good standing in said unincorporated body, at a business meeting called, in accordance with the Constitution of this body. A two-thirds (2/3) majority of members in good standing, attending and voting at the specified business meeting shall constitute approval, subject to the approval of the Secretary of the State of Florida, as required by law.

Article XVI (Dissolution)

Upon dissolution or winding up of this corporation, its assets remaining after payment, or provision for payment of all debts and liabilities of the corporation shall be distributed to a non-profit fund, foundation, or corporation which is organized and operated exclusively for religious purposes, and which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code of 1954, or corresponding provisions of any subsequent federal tax laws.

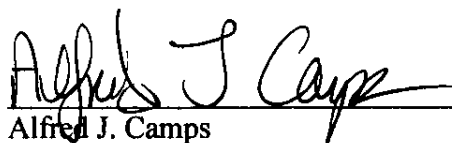
