**ARTICLES OF INCORPORATION OF  
VICTORY OUTREACH NORTH MIAMI, INC.  
A RELIGIOUS NON-PROFIT CORPORATION**

- ARTICLE I:** The name of this corporation is **Victory Outreach North Miami, Inc.**
- ARTICLE II:** The principle place of business is 1145 NW 125<sup>th</sup> Street, North Miami, Florida 33168. The mailing address is P.O. Box 610187, North Miami, Florida 33261.
- ARTICLE III:** This Corporation is a nonprofit religious corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Religious Corporation law primarily for religious purposes. The specific purposes for which this corporation is organized are to operate a church for the promulgation of the gospel of Jesus Christ, the rendering of Christian service, through spiritual and educational means to those in need. Towards this end we plant and develop churches, rehabilitation homes and training centers and work in collaboration with other Churches and organizations of similar purpose. (a) This corporation is organized exclusively for religious purposes within the meaning of Section (501)(c)(3) of the Internal Revenue Code.  
(b) Notwithstanding any other provisions of these Articles, the corporation shall not carry on any other activities, not permitted to be carried on (1) by a corporation exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code of 1954 (or corresponding section of any future federal tax code), or (2) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1954 (or corresponding section of any future federal tax code).  
(c) No substantial part of the activities of this corporation shall consist of the carrying on of propaganda or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in any political campaign (including the publishing or distribution of statements), on behalf of, or in opposition to, any candidate for public office.
- ARTICLE IV:** The manner in which the Directors are elected or appointed is by Self Perpetuating Boards.

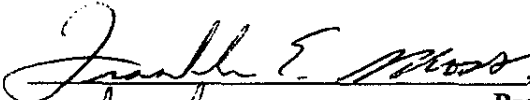

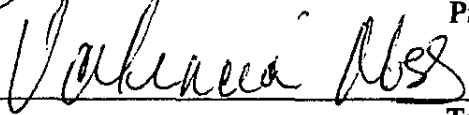
**ARTICLE VIII:** Victory Outreach North Miami, Inc. is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.


**ARTICLE IX:** The property of this corporation is irrevocably dedicated to religious purposes and no part of the net income or assets of this organization shall ever inure to the benefit of any director, officer, or member of thereof, or to the benefit of any private person. Upon the dissolution of the corporation assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, or to another nonprofit, religious corporation for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
