ARTICLES OF INCORPORATION

THE PAY 1:48 CONGRESS FOR RENAISSANCE OF IVORY COAST POLITICAL ACTIO COMMITTEE, INC.

The undersigned acting as incorporator(s) of a Corporation pursuant to Chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation of such corporation:

ARTICLE I

The name of the corporation shall be:

CONGRESS FOR RENAISSANCE OF IVORY COAST POLITICAL ACTION COMMITTEE, INC.

The principal place of business of this corporation shall be: 18800 NW 2nd Ave. Ste 202 Miami Gardens, FL 33169

ARTICLE II

The period of the duration of this corporation is Perpetual Filing with the Secretary of State unless dissolved according to law and shall engage in any activity or business permitted a nonprofit entity under the laws of the United States, of the State of Florida.

ARTICLE III

The purpose (purposes) for which the corporation is organized is (are): This is a nonstock, non-profit corporation. This corporation will engage in, but shall not be limited to the following activities:

- a. To serve as the campaign committee for the Congress For Renaissance of Ivory Coast
- b. To borrow money and issue evidences of indebtedness in furtherance of any and all of the purposes of the business of the corporation, and to secure the same by mortgage, pledge or other lien on corporation's property
- c. To contribute funds to the political party committee of the Congress For Renaissance of Ivory Coast
- d. To make independent or coordinated expenditures in support of political candidate of the Congress For Renaissance of Ivory Coast
- e. To engage in educational, advertising and promotional activities
- f. To solicit, collect, receive and administer funds
- g. To contract for the purchase of goods and services
- h. To rent and maintain office space
- i. To hire and fire employees
- j. To sell, convey and dispose of any property and invest and reinvest the property held
- k. To deal with and distribute the corporation's income and assets in such manner as in the corporation's judgment will best promote its purposes; and

1. In general, to enter into any kind of activity, to make and perform any contract and to exercise all powers necessary, incidental or convenient to the administration. management, maintenance, repair, replacement and operation of the corporation's assets and activities and to the accomplishment of any of the purposes of the corporation not forbidden, and with all powers conferred upon nonprofit corporations by the laws of the State of Florida.
