ARTICLES OF INCORPORATION

This is to certify that we, the undersigned natural persons, of age eighteen (18) years of age or more, all of whom are citizens of the State of Florida, acting as incorporators of a not for profit, non stock corporation under Chapter 617, Florida Statutes (F.S.), do hereby adopt the following Articles of Incorporation for such corporation:

ARTICLE I Name

The name of the corporation (hereinafter called the "Corporation") is "The Florida Wind Band, Inc."

ARTICLE II Principal Office

The principal office of the Corporation shall be located at 4202 E. Fowler Ave, FAH 208 Tampa, Florida 33620-7350. The mailing address of the Corporation shall be 5004 E. Fowler Ave, #C140 Tampa, FL 33617.

ARTICLE III Purpose

The purposes for which the Corporation is formed are:

- (a) The Corporation is organized and shall be operated exclusively for charitable, religious, scientific, literary or educational purposes within the meaning of Section 501(c) (3) of the Internal Revenue Code of 1954, as amended, or the corresponding provision or provisions of any subsequent United States Internal Revenue law or laws (hereinafter collectively call the "Code").
- (b) no part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to, its directors, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these Articles. No substantial part of the activities of the Corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation (except that, if the Corporation so elects, it may make such expenditures in conformity with

§501(h) of the Internal Revue Code) and the Corporation shall not participate in or intervene in (including publishing or distribution statements) any political campaign on behalf of, or in opposition to, any candidate for public office. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on: (a) by a corporation exempt from Federal Income Tax under §501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law), or (b) by a corporation, contributions to which are deductible under §170(c)(2) of the Internal Revenue Code 1986 (or the corresponding provisions of any future United States Internal Revenue Law).

- (c) Included among the educational, literary and charitable purposes for which the Corporation is organized, as qualified and limited by subparagraph (a) of this Article IV are the following:
 - (1) Within the scope of the foregoing purposes, and not by way of limitation thereof, the Corporation is organized to publicly perform wind band music, promote new music for the wind band medium, and preserve the wind band musical heritage through concerts, recordings, publications and clinics. The assists and properties of the Corporation are hereby pledged for use in performing exempt functions.
- (d) To do all and everything necessary, suitable and proper for the accomplishment of any of the purposes or the attainment of any others or the furtherance of any of the powers earlier set forth, either alone or in association with other corporations, firms or individuals and to do every other act or acts, thing or things, incidental or appurtenant to or growing out or connect with the aforesaid objects or purposes of any part or parts thereof, provided the same are not inconsistent with the laws under which this corporation is organized.
- (e) No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting, to influence legislation (except as provided by §501(h) of the Code), and the Corporation shall not participate in, or intervene in (including the publication or distribution of statements) any political campaign on behalf of any candidate for public office.

ARTICLE IV Management by Directors

The affairs of the Corporation shall be managed by a Board of Directors, the number which shall not be less than 3; and the exact number shall be fixed by the bylaws of the Corporation. At or before each annual meeting of the Directors, they shall appoint such Directors to manage the affairs of the Corporation for the ensuing year or until their successors are duly appointed as provided for in the Bylaws; and those Directors shall be appointed from nominations submitted pursuant to the provisions of the Bylaws.

(a) The Directors of the Corporation may from time to time engage investment counsel, trust corporation, or banks possessing trust powers and confer on any such advisor full power and authority to purchase or otherwise acquire stocks, bonds, securities, and other investments on behalf of the Corporation, and to sell, transfer, or otherwise dispose of any of the Corporation's assets and properties at such time and or for such consideration as such advisor may deem appropriate. The Directors may also confer on any such advisor to hold title to any of the Corporation's assets and properties in its own name or in the name of a nominee, and the Directors shall have no liability whatsoever with respect to any action taken or omitted by such advisor provided the advisor was selected with due care by the Directors. The Directors may remove or replace any such advisor if they deem such action appropriate or necessary.

This Corporation shall have perpetual existence.

ARTICLE X Dissolution

Upon the dissolution of the Corporation, the Board of Directors shall, after paying or making provision for the payment of all the liabilities of the corporation, dispose of all the assets of the Corporation in such manner or to such organization or organizations organized and operated exclusively for charitable, religious, scientific, educational, or such other exempt purposes as shall at the time qualify as an exempt organization or organizations under §501©(3) of the Internal Revenue Code of 1986 or corresponding provision of any future United States Internal Revenue Lay), or to a federal, state, or local government body to be used for exclusively public purposes as the Board of Directors shall determine.
