

#### Articles of Incorporation

## IN RE: INCORPORATION OF NEW LIFE PRAISE & WORSHIP CENTER, INC.

3701 NW 28th Court Lauderdale Lakes, Florida 33311

WE THE UNDERSIGNED, propose to become a religious corporation under the laws of the State of Florida, providing for a non-profit religious institution under a charter as follows:

#### ARTICLE I

The name of the corporation shall be NEW LIFE PRAISE & WORSHIP CENTER, INC and it is to be located in the State of Florida, County of Broward.

#### **ARTICLE II**

The general purpose and plan of operation of this corporation shall be to establish and operate a religious, social, and educational center in Broward County, Florida, to buy, to manage, to own and to hold real and personal property necessary and proper for a religious, social, and educational ministry to carry on charitable work, and to contribute to the growth and development of this community.

#### ARTICLE III

The terms of admission and qualification for membership in this corporation shall be by application, written or oral and approved by appointment by the Chief Executive officer. Any person desiring to aid this corporation and interested in addressing the religious, educational and social needs of this community, and is a member of the NEW LIFE PRAISE & WORSHIP CENTER, INC, is eligible to become a member of the board of directors.

#### ARTICLE IV

The officers of this corporation shall be the Board of Directors. The Board of Directors will consist of: the Chief Executive Officer, the President, the Vice President the Treasurer, and the Secretary. They shall have charge of the temporal affairs of NEW LIFE PRAISE & WORSHIP CENTER, INC. The Board of Directors shall consist of not less than three or more than nine members appointed by the Chief Executive Officer, pending the Senior Pastor's approval. The Board of Directors shall have the power to buy, own, control, mortgage, and manage all personal and real property of the corporation.

#### ARTICLE V

This corporation is to have perpetual existence.

#### ARTICLE VI

#### ARTICLE VII

The affairs of the corporation are to be managed by the Board of Directors. Upon dissolution of the corporation, the CEO or his/her designee shall, after paying or making provisions for the payment of all of the liabilities of the corporation, dispose of all of the assets of the corporation exclusively for the purposes of the corporation in such manner, or to such organizations organized and operated exclusively for charitable and educational purposes as shall at the time qualify as an exempt organization or organization under section 501 © (3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law), as the Chief Executive Officer or his/her designee shall determine. Any such assets not so disposed of shall be disposed of by the Court of Broward County in which the principal office of the corporation is then located, exclusively for such purposes or to such organizations as said court shall determine which are organized and operated exclusively for such purposes.

#### **ARTICLE VIII**

#### ARTICLE IX

A committee of no less than three and no more than seven members of the Board of Directors may adjust the by-laws at any time. The Chief Executive Officer shall appoint this committee. The committee may not meet, act, and/or vote without the CEO's written permission.

The majority of a committee appointed by the Chief Executive Officer may adopt amendments to these Articles of Incorporation.

#### ARTICLE XI

The amount of real estate, which this corporation may hold subject to the approval of the Secretary of State, is FIFTEEN MILLION DOLLARS (\$15,000,000.00).

#### ARTICLE XII

The highest amount of indebtedness of liability to which this corporation may at any time subject itself shall never be greater than two-thirds (2/3) of the total value of property owned by the corporation unless approved by the Secretary of State in an amount not to exceed the total value for the property owned by the corporation.

#### **REGISTERED AGENT**

The registered agent of the NEW LIFE PRAISE & WORSHIP CENTER, INC. is LEROY SMITH. The registered agent may be changed in a manner provided by law.
