**ARTICLES OF INCORPORATION
OF RELEVANT LIFE CHURCH, INC.**

ARTICLE I: NAME

The name of the corporation shall be RELEVANT LIFE CHURCH, INC.

ARTICLE II: PRINCIPLE OFFICE

The place in this state where the principal office of the Corporation is to be located is 4913 Spears Street in the City of Pace, Florida, Santa Rosa County.

ARTICLE III: PURPOSE

This corporation is organized exclusively for charitable, religious, and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE IV: LIMITATIONS

The powers of the corporation to promote the purposes set out above are limited and restricted in the following manner:

(a) No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

(b) Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE V: TERM

The term for which this corporation shall exist shall be perpetual.

ARTICLE VI: DISSOLUTION

Upon the liquidation, dissolution or winding up of the Corporation, the Mission Leadership Team of the Corporation shall, after paying or making provision for making payment of all the liabilities of the Corporation, distribute all Corporation to any organization designated by the Mission Leadership Team of the Corporation which is of like faith and order and is exempt from taxes under Internal Revenue Code Section 501(C)(3) or the corresponding provision of any future tax law of the United States.

ARTICLE VII: MANNER OF ELECTION

Be it resolved that the Directors of this corporation hereby be appointed by the Nomination Advisory Team. A two-thirds vote is necessary for approval. The election process for each nominee will include: a resume', consultation with Senior Pastor and team members, background check, and the application of 1 Timothy 3:1-11 and Titus 1: 5-9 (RELEVANT LIFE CHURCH, INC. Bylaws Section 5.1).

ARTICLE VIII: AMENDMENTS

Amendments to these Articles may be made at an informal meeting called by the Senior Pastor. Such changes or amendments shall be presented in printed form to all of the Mission Leadership Team present. It shall require a two-thirds (2/3) majority vote of the Mission Leadership Team present and voting to become effective.

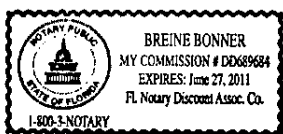
