# Bridges Across Borders Southeast Asia, Inc.

## ARTICLE III PURPOSE is amended to read as follows:

The purpose for which the corporation is organized is:

Bridges Across Borders Southeast Asia (BABSEA) is an international grassroots organization working to bring people together to overcome poverty, injustice and inequity in the Southeast Asia region.

We are building bridges across borders by:

- θ Raising global awareness of the pressing issues facing people in Southeast Asia
- θ Facilitating people-to-people and educational exchanges, cross-cultural dialogue and volunteer programs
- $\theta$  Supporting local struggles for social justice, equitable development and the protection of human rights
- θ Teaching creative, non-violent methods of resolving conflict and redressing injustice

The corporation is organized exclusively for charitable and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

The following is added as Article VIII:

## ARTICLE VIII DISTRIBUTION OF ASSETS UPON DISSOLUTION OF CORPORATION

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by the Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

The following is added as Article IX:

## ARTICLE IX ADDITIONAL PROVISIONS

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its directors or officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
