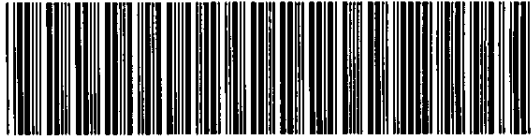

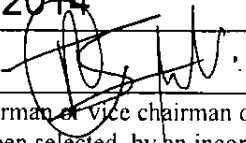

ARTICLES OF CORRECTION OF IGLESIA T.N. CRISTO INC,
a Florida non profit corporation.

ARTICLE I

The name of the corporation is: **IGLESIA T.N. CRISTO INC**

ARTICLE II:

The principal offices of the non-for-profit Corporation shall be located at 2206 W ATLANTIC AVE SUITE 101, DELRAY FLORIDA 33445.

Other offices for the transaction of business may be located wherever the Director may deem necessary or expedient.

ARTICLE III:

This corporation shall have perpetual existence and may engage in any activity or business permitted under the laws of the United States and of the State of Florida, and under Section 501(3) of the Internal Revenue Code.

The general nature of the business to be transacted by this non-for profit corporation shall be any and all legal business transactions in the State of Florida as a non-profit-corporation with purpose of disseminating the Word of God and the Gospels of Jesus Christ.

Worship. To establish and maintain a place for the worship of the living God, in spirit and truth, in order for us to open ourselves to the glory of Jesus Christ, in order to carry on his Ministry and be transformed into his image.

Teaching. To teach the word of God as the sole authority and infallible norm of faith and conduct, the development of the ministries that the Spirit bestows upon the church, the preparation of church members to serve the body (the church), perfect church members to the measure of the stature of the fullness of Christ, to grow in the unity of the faith and in the knowledge of the Son of God.

Communion. To encourage and promote unity among church members. to edify the body of Christ with the interdependence of church members, to develop love among one another, to minister and aid one another in their needs, to encourage brotherhood with all brethren in the faith.

Evangelism. To reach and disciple, creatively, the lost souls of our community, to be the salt of the earth and the light of world, to establish new churches, to cooperate with missionaries, missionary and autochthonous organizations in order to bring the Gospel to the whole world. To establish and maintain departments and institutions that will help in the fulfillment of the Great Commission, such as orphans' houses, retirement homes, Christian schools, Biblical institutions, daycare centers, rehabilitation centers and others.

ARTICLE IV: PREROGATIVES

This church shall have the right to govern itself, in conformity with the norms set down in the New Testament. *"Endeavoring to keep the unity of the Spirit in the bond of peace"...*

till we all come in the unity of the faith and of the knowledge of the Son of God unto a perfect man, unto the measure of the stature of the fullness of Christ" Ephesians 4:3,13.

This church, in a direct and incidental relationship to the prerogative of governing itself, is entitled to buy, acquire through donations, successions, inheritances or otherwise, either directly, or as a depository; the church shall be entitled to own, administer, utilize, dispose of, sell, transfer, mortgage, lease or otherwise dispose of both real estate and tangible property, as may be necessary for the encouragement or defense of its interests an purposes, in conformity with its current Constitution and Bylaws, or with the modifications or amendments that these might undergo in the future.

This church, in a direct and incidental relationship with the prerogative to govern itself, is entitled tot acknowledge and provide ordinance to its own ministers and church officials, in conformity with its current Constitution and Bylaws, or with the modifications or amendments that these might undergo in the future.

ARTICLE V: STATEMENT OF FAITH

1. We believe that the Bible is the sole word of God. We believe it is inspired, infallible and that it has authority. We believe in the full and literal inspiration of the Old and New Testaments, as originally given. The Bible stands above both human consciousness and reason, but not contrary to it. We shall speak where the Bible speaks and shall remain silent wherever the Bible remains silent. // *Timothy 3:16; II Peter 1:20, 21.*

2. We believe in the only and True God, eternally existing in three persons: The Father, the Son and the Hoy Spirit, distinguishable, but indivisible. *Deuteronomy 6:24; Matthew 28:19; Luke 3:22.*

3. We believe in the Divinity of Christ, in His virgin birth, in His life without sin, in His miracles, in His vicarious and atoning death, through His blood, that was spilled on the cross, in His bodily resurrection, in His ascension to Heaven, where He is at the right hand side of the Father, in His present priestly ministry. *Luke 1:26-35; John 1:14, 18; Isaiah 7:14, 9:6; Corinthians 15:1-4; Romans 4:25; John 14:2, 3; Thessalonians 4:13-18.*

4. We believe that man was created good and just, in God's image, and that man fell by a willful transgression, through which, not only did man came to know physical death, but also, spiritual death, which consists in man's separation from God. *Genesis 1:26, 27; 2:17; 3:1-7; Romans 5:12-21.*

5. We believe that human life is of an inestimable value and significance in all its manifold dimensions, from the moment of conception and unto the grave. *Genesis 1:27, Psalms 139:13, 14.*
6. We believe in the missionary fervor and effort. *Mark 16:15; Matthew 28:19-20; The Acts 1:8.*
7. We believe in the salvation of sinners through the grace of God and their regeneration and renewal through the Holy Spirit. We believe in God's power of transformation. Although the work of salvation is entirely dependent on God's grace, God has given man free will through which he may reject, accept or leave this divine grace. *Ephesians 2:8, 9; Hebrews 6:1-6; 9:12; Romans 5:11; Peter 2:21.*
8. We believe that God's will unto His church lies in sanctification and the purity of heart, in a just life, devoted to His purposes and designs. *Ephesians 5:27.*
9. We believe that sexual purity is a necessary expression for all of God's children and requires abstaining from adultery, fornication, incest, homosexuality or other sex relations or practice banned by Scripture. *Leviticus 18:1-30; I Corinthians 6:18; Hebrews 13:4.*
10. We believe that marriage is the union of a man and a woman, in a covenant and commitment of a lifetime and a sacred institution, established by God. *Genesis 2:18-25; Matthew 19:3-9; Ephesians 5:21-33; I Corinthians 6:9, 10; Titus 1:6, 1 and Timothy 3:2, 12.*
11. We believe in the Bible's Ordinances:
 - a. Baptism, by water, which must be performed by immersion, as commanded by Scripture, by all those who have repented in their hearts and who have believed and confessed before Jesus Christ as Lord and Savior.
 - b. The Lord's Supper, consisting of the elements, that is, bread and wine, is a symbol that expresses our participation in the divine nature of our Lord Jesus Christ, in memory of his death and as a prophecy of his second coming. *Matthew 28:19; Romans 6:4; I Corinthians 11:23-26.*
12. We believe in baptism in the Holy Spirit as an experience leading to salvation, with the scriptural evidence, mainly, such as the gift of speaking in tongues, as the Holy Spirit gives us, for us to speak. In the operation of the gifts and ministries of the Spirit, as He bestows them upon the church. In the life of the fullness of the Spirit, a life of separation from the world; filled with all the fruits of the Spirit, walking toward perfection in sanctity in the fear of the Lord, by subjecting ourselves to His will, as an expression of faith and love. *Acts 2:1-4; 8:14-17; 10:44-46; Galatians 3:14, 15; 6:1-13; I Corinthians 12-14; Ephesians 4:11-16; 5:18; Corinthians 6:14; 7:1; Romans 6:1-13; 12:1, 2; Philippians 2:12, 13.*
13. We believe that the Church is the body of Christ, the abode of God through His Spirit, with divine designations for the fulfillment of the Great Commission. Every believer, born of the Spirit, becomes an integral part of the Church, which is recorded in Heavens. Every believer in Christ shall be subject to God's authority, in a particular, local church, for the sake of spiritual protection and lasting results. *Ephesians 1:22-23; Hebrews 12:23, 13:17.*

14. We believe in the personal, visible and imminent return of Christ, in full power and Glory, in His present and eternal domain. *Matthew 24:27, 30; Acts 1:11; Apocalypse 1:7.*

15. We believe in the resurrection of the dead, both of the faithful as well as of the faithless, with the former to be resurrected to life and the latter for damnation. *Matthew 25:46; John 5:28, 29; Apocalypse 19:20; 20:10-15.*

16. We believe in the new Heavens and the new Earth, in which God's justice rules. *Peter 3:13; Apocalypse 12:22.*

ARTICLE V. MEMBERSHIP

Membership in the church shall be open to all those who evidence a true faith in Our Lord and Savior Jesus Christ and who voluntarily accepts the Statement of Faith and stands ready to abide by its Constitution and its Bylaws.

Anyone who meets the stipulated membership requirements and has faithfully attended worship sessions and activities during a three-month period, and is 16 years old, or older. The Pastor and the Body of Elders are the final authorities for member acceptance. Members are the legal body of the church and shall have a voice and the right to vote. Members shall be at least twenty-one years old before they are allowed to join any official body of the Church and to cast a vote in required elections.

ARTICLE VI. SPIRITUAL LEADERSHP AND OFFICIALS

The biblical form of government of the local church consists of a plurality of ministries and leadership gifts, which are subjected to the direction of the Holy Spirit and the Scriptures. Jesus Christ is the Lord of His church, from which we accept theocratic government.

There shall be a main Pastor, who bears ultimate responsibility over the church and the obligation to render accounts before God about it.

There shall be a Body of Elders, consisting of the Pastor and the Elders. The elders shall be appointed by the Pastor, by common agreement with all other elders and shall be presented by the church; and shall share the spiritual guidance of the church with the Pastor.

There shall be a Body of Deacons, which shall consist of laborers and ministers, according to the needs of the church. The Deacons shall be appointed by the Pastor, by common agreement with all other Deacons and shall be presented by the church; and shall share the spiritual guidance of the church with the Pastor.

There shall be a Body of Laborers, which shall consist of all those who consistently and systematically discharge responsibilities and tasks within the church. The laborers shall be appointed by the Pastor, by common agreement with the Body of Elders, according to the needs of the church.

There shall be a Board of Directors, which shall consist of the officials of the corporation: The Chairman, the Assistant Chairman, the Secretary, the Treasurer and the Vocal. The Pastor shall be the Chairman of the Board.

ARTICLE VII. MEETINGS

The Pastor and the Elders shall establish the schedule of public worship, their contents and their order.

Informational meetings for members shall be held, whenever the Pastor deems it necessary.

The Pastor shall call business meetings for members shall be held at least once every year. *Additional business meetings shall be held whenever the Pastor deems it necessary.* The Body of Elders may call for a business meeting to deal with Pastor's discipline, or to vote for a new Pastor. Such meetings shall be called for two Sundays in advance of the date of the Meeting.

The Body of Elders and the Board of Directors shall meet to discharge their obligations whenever necessary and, in addition, when the Pastor calls for a meeting.

A business meeting shall have a quorum whenever one half plus one members are in attendance.

ARTICLE VIII. FINANTIAL

All funds utilized for church support shall proceed from the voluntary contributions of its members and sympathizers, through tithes and offerings. The offerings shall be received by the church on the dates and in the manner prescribed by the main Pastor. These funds shall be managed by the Treasurer, under the direction of the main Pastor, and the Board of Directors.

ARTICLE IX. PROPERTIES

All church properties shall be deeded to the church and shall be managed by the Board of Directors. No church property worth more than \$20,000.00 shall be sold, leased or mortgaged, and shall not be otherwise disposed of, unless such sale, lease, mortgage or disposition has been approved in advance, by approval of two thirds of attendees to a meeting that has been called for that purpose. Should the sale, transfer, lease, mortgage or disposition be approved, the Chairman and the Secretary shall certify the transaction on behalf of the church. This certification shall be kept as conclusive evidence of such an action.

In case of dissolution, no part of net earnings, properties or goods of this corporation shall be used for the benefit of any person or individual, or any member or official of the church; in all cases, all the properties and goods of this church that remain after all outstanding church debts and obligations have been paid off shall be given to the Christian Church begging from under a year, that fulfils article IV of our constitutions, for the institution and development of your church.

ARTICLE X. SEAL

The seal of this church shall bear the following words: **IGLESIA T.N. CRISTO INC.**

ARTICLE XI. FISCAL YEAR

The fiscal year of this corporation shall open with January the first of every year.

ARTICLE XII. AMENDMENTS

This Constitution may be amended through the favorable vote of two thirds of the attendees of a meeting called for this purpose, provided that the change has been advertised, at least, two Sundays in advance of said meeting. It shall be understood that this does not apply to the Statement to Faith.

ARTICLE XIII:

The initial officers and Board of Directors of this non-profit corporation shall serve until the first election and organized as follows:

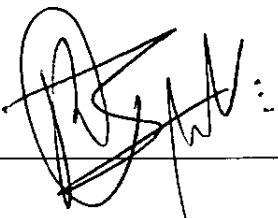
