ARTICLES OF INCORPORATION  
Of  
MS VIEWS AND RELATED NEWS, INC.

Pursuant to Chapter 617 of the Florida Statutes, as may be amended from time to time (the "Act"), the following shall be the Articles of Incorporation for MS Views and Related News, Inc.:

ARTICLE I NAME

The name of the corporation shall be: MS Views and Related News, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal street address of MS Views and Related News, Inc. is: 777 NW 72<sup>nd</sup> Avenue, Suite 3005, Miami, Florida 33126, and mailing address: 8669 SW 51<sup>st</sup> Street, Cooper City, FL 33328-4301.

ARTICLE III EXISTENCE & PURPOSE

The existence of MS Views and Related News, Inc. shall be on the date of filing and continue in perpetuity. The purpose for which the corporation is organized is:

MS Views and Related News, Inc. is organized exclusively for charitable, scientific and educational purposes related to multiple sclerosis services. To this end, the corporation shall at all times be operated exclusively for charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended. All funds, whether income or principal, and whether acquired by gift or contribution or otherwise, shall be devoted to said purposes.

ARTICLE IV POWERS

The powers of the MS Views and Related News, Inc. shall be exercised by or under the authority of, and the business and affairs of the MS Views and Related News, Inc. shall be managed under the direction of the board of directors of MS Views and Related News, Inc. in accordance with the bylaws of MS Views and Related News, Inc. adopted in accordance with the provisions of the Act (the "Bylaws"). The powers to adopt, alter, amend or repeal the Bylaws of the MS Views and Related News, Inc. shall be vested in the board of directors of the MS Views and

Related News, Inc. At all times the following shall operate as conditions restricting the operations and activities of MS Views and Related News, Inc. :

1. No part of the net earnings of MS Views and Related News, Inc. shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purpose set forth in the purpose clause hereof.
2. No substantial part of the activities of MS Views and Related News, Inc. shall constitute the carrying on of propaganda or otherwise attempting to influence legislation, or any initiative or referendum before the public, and the corporation shall not participate in, or intervene in (including by publication or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.
3. Notwithstanding any other provisions of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170 (c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

#### ARTICLE V INITIAL DIRECTORS

#### ARTICLE VI INITIAL REGISTERED AGENT AND STREET ADDRESS

#### ARTICLE VII PERSONAL LIABILITY

No Member, Officer, or Director of MS Views and Related News, Inc. shall be personally liable for the debts or obligations of MS Views and Related News, Inc. of any nature whatsoever, nor shall any of the property of the Member, Officer, or Director be subject to the payment of the debts or obligations of this MS Views and Related News, Inc.

## ARTICLE VIII DISSOLUTION

Upon the dissolution of MS Views and Related News, Inc., assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of by the District Court of the county in which the principal office of MS Views and Related News, Inc. is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine which are organized and operated exclusively for such purposes.




