

Restated Articles of Incorporation

A Life for a Life International Inc.

Florida Not for Profit Corporation

The undersigned hereby adopts the following articles of incorporation in Compliance with Chapter 617, F.S., (Not for Profit).

Article 1 Name

The name of this corporation shall be A Life for a Life International Inc.

Article 2 Principal Office

The principal street and mailing address is 5681 Edenfield Rd., Apt. 101, Jacksonville, FL 32277.

Article 3 Purpose

The specific purpose for which the corporation is initially organized is to establish and oversee places of worship, conduct the work of evangelism, create departments necessary to support missionary activities, to license, ordain and oversee ministers of the gospel and to also engage in activities which are necessary, suitable or convenient for the accomplishment of that purpose, or which are incidental thereto or connected therewith which are consistent with Section 501(c)(3) of the Internal Revenue Code.
