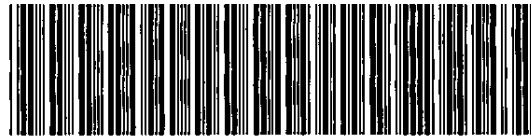

Pursuant to the provisions of section 617.1006, Florida Statutes, this Florida Not For Profit Corporation adopts the following amendment(s) to its Articles of Incorporation:

### Amendments Adopted


**Please amend Article 3 Purpose to read as follows:**

The specific purpose for which the corporation is organized is to establish and oversee places of worship, to be a governing entity which will establish governance and polity, oversee activities, enforce common doctrines, and provide general administrative and spiritual supervision for other organizations which will themselves be organized and operated exclusively for educational, charitable, and/or religious purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 and shall voluntarily be partnered with this organization, to conduct the work of evangelism worldwide, create departments necessary to support missionary activities, provide practical support to the community, to establish and oversee one or more public and/or private educational institutions, and to license and oversee ministers of the gospel and to also engage in activities which are necessary, suitable or convenient for the accomplishment of that purpose, or which are incidental thereto or connected therewith which are consistent with Section 501(c)(3) of the Internal Revenue Code. This corporation is organized and operated exclusively for religious purposes within the meaning of Section 501(c)(3), Internal Revenue Code.

The date of adoption of the amendment(s) was September 15, 2014.
