In Compliance with Chapter 617, F.S., (Not for Profit)

The undersigned, desiring to form a corporation not for profit, pursuant to the laws of the State of Florida, as contained in Chapter 617 of Florida Statutes, hereby certify as follows:

ARTICLE I - CORPORATE NAME:

The name of the Corporation shall be: BIG - SIS, Inc.

ARTICLE II - PRINCIPAL OFFICE:

ARTICLE III - PURPOSE:

The purpose for which the corporation is organized is:

The corporation is not organized for the private gain of any person. Said corporation is organized exclusively for charitable, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

More specifically, BIG SIS, Inc. is a nonprofit organization that works to create opportunities for positive change in the lives of women and young girls. BIG SIS, Inc., is dedicated to the reintegration and empowerment of these women in becoming independent, goal-oriented and self-sufficient into society.

ARTICLE V - MANNER OF ELECTIONS

The directors shall be elected or appointed as established through the Bylaws of the corporation.

ARTICLE VI - LIMITATION OF CORPORATE POWERS

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for

Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.
