ARTICLES OF INCORPORATION

H08000260252

The undersigned, acting as incorporator(s) of a corporation pursuant to chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:

ARTICLE I NAME

The name of the corporation shall be:

The Hope Collection Inc.

ARTICLE II PRINCIPAL

Principal place of business and mailing address

The principal place of business and mailing address of this corporation shall be:

ARTICLE III PURPOSE(S)

The purpose of Hope's Collection is to supply funds that will:

- 1. Aid in cancer research and support for victim's, their families, businesses and causes through, but not limited, Performing and Fine Arts organization as well as their National Association of Basketball Coaches, Coaches vs. Cancer initiative.
- 2. Aid projects that provide Substantial and Sustainable Social and Economic Growth that help support the Family Unit and break the poverty cycle, i.e., infrastructure development, education, Faith-based initiatives, technology education and deployment, communications, waste and water remuneration, energy conversion, affordable housing, and the arts.

Included but not limited to the following:

Building Green "Hope's Homes" for Veterans, Single Parents; 55+ with some medical or other disenfranchisement, Emotionally and Physically Challenged and collaborating with existing Faith Based organizations as well as Easter Seals, Ronald McDonalds homes and NYC Relief etc as part of Attainable Housing projects.

Purchasing and/or building Green "Hope's Hubs" Job and Economic Development Centers including Malls, preventative Health Research and Dietary Delivery Centers, Rehabilitation of existing city buildings, Waste Remuneration and Energy Conversion and Commercial Flex properties to do onsite job and small business training.

Establishing "Carl's Classes" for Continuous Progress education for Job and Small Business Training to build people who Pay-it-Forward and can sustain/duplicate the out reach process by acting as "Hope's Heroes" for others. Includes other citizens such as professional athletes, artists, employees and business people.

- 3. No geographical restriction for programs.

Said organization is organized exclusively for charitable, religious, educational and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distributions of statements) and political campaign on behalf of any candidate for public office.

Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from Federal income tax under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future tax code, or (b) by an organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future Federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization of organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.


