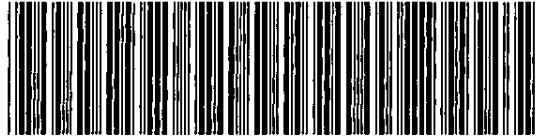

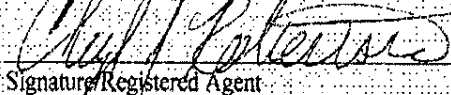

**ARTICLE III PURPOSE**

**Fraternal and Charitable**, so that no part of the net earnings of the Corporation shall inure to the benefit of, or be distributed to its members, trustees, officers, or other private persons except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions to the furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, Or intervene in (including the publications or distribution of statements) any political campaign on behalf or in opposition of any candidate for public office. Notwithstanding any provision of these articles, this Corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purpose of this Corporation.

Upon dissolution of the Corporation assets will be distributed to the Grand Aerie for distribution for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future tax code, exclusively for such purpose or to such organization or organizations which are organized and operated exclusively for such purposes.
