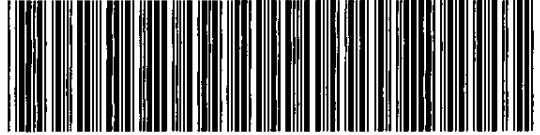

**Articles of Incorporation
Of
My Angel With Paws, Inc.**

The undersigned Incorporator, who is a natural person, is a resident of Florida, is of legal age, and is competent to contract, hereby forms a corporation not for profit under the laws of the State of Florida.

ARTICLE I – Name of Corporation

The name of this corporation shall be 'My Angel With Paws, Inc.'

ARTICLE II – Address of Principal Office

The street address of the initial principal office of the corporation and also the mailing address is, 3098 Marsh Road, DeLand, FL 32724-9011.

**ARTICLE III – Purpose for which Organized, and Distribution of Assets upon
Dissolution**

The primary purpose and objective of this Corporation shall be the training of animals to be used to provide assistance and therapy to persons with disability or persons who are ill, in nursing homes, children facilities, or other convalescent homes and to carry on such activities that are permitted by and not prohibited to corporations not for profit under the laws of the State of Florida and which are exempt from Federal Income Tax under section 501(c)(3) of the United States Internal Revenue Code of 1986 or the provision of any future United States Revenue law, Notwithstanding any other provisions of these articles.

- A. The purposes for which the Corporation is organized are exclusively religious, charitable, scientific, literary and educational within the meaning of Section 501(c)(3) of the United States Internal Revenue Code of 1986 or the provision of any future United States Revenue law.
- B. This corporation shall not carry on any activities not permitted to be carried on by a corporation exempt from Federal Income Tax under Section 501(c)(3) of the United States Internal Revenue Code of 1986 or the provision of any future United States Revenue law.
- C. Upon dissolution of this corporation, its assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the United States Internal Revenue Code of 1986 or the provision of any future United States Revenue law, or shall be distributed to the Federal, State, or local government for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction, in the county in which the principal office of the Corporation is then located, exclusively for such purposes.

ARTICLE IV – Directors

All corporate powers must be exercised by or under the authority of, and the affairs of the corporation managed under the direction of a board of directors. The number of directors of the corporation and their method of election shall be as provided by and stated in the By-Laws and may be changed by amendment to the By-Laws.




