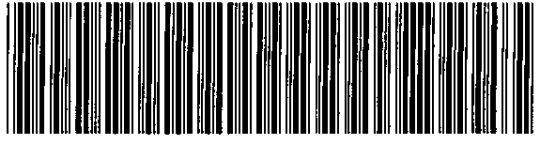

**ARTICLES OF INCORPORATION  
OF  
ARMOR OF GOD INTERNATIONAL CHAPLAINS, INC.**  
In Compliance with Chapter 617, F.S. (Not for Profit)

**ARTICLE I**

The name of the Corporation shall be ARMOR OF GOD INTERNATIONAL CHAPLAINS, INC. a Florida not for Profit Corporation

**ARTICLE II**

This Corporation shall exist perpetually.

**ARTICLE III**

The principal place of business and mailing address of this Corporation shall be:

**ARTICLE IV**

**General Purpose:** The general purpose for which the Corporation is organized are exclusively religious, charitable, and educational within the meaning of Section 501 (c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Code.

**Specific Purpose:** Prepare Christian workers to help their neighbor in all concepts of being a chaplain. Preach the Gospel of Jesus. Supply orientation, training materials and instructions to groups and individual who are interested in participating in our programs. Provide assistance to people or countries in need. To visit convicts at any institution, to help the needy, to refer people with different needs to the appropriate institutions and organizations with help available. To give help and spiritual counseling.

**ARTICLE V**

This corporation shall issue no stock. No part of the net earning of the corporation shall inure to the benefits of any member, director, or officer of the corporation or any private individual (except that reasonable compensation may be paid for services rendered and to make payments and distributions in furtherance of the

purposes set forth in Article Fourth hereof) and no member, director, or officer of the corporation or any private individual shall be entitled to share in the distribution of any of the corporation assets upon dissolution of the corporation. No substantial part of activities of this corporation shall consist of the carrying on of propaganda, or otherwise attempting, to influence legislation. This corporation shall no participate or intervene in any political campaign on behalf of any candidate for public office, including the publishing or distribution of statements. Notwithstanding any other provision of these articles, this corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under 501 (c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States internal revenue law, or by a corporation, contributions to which are deductible under 170(c)(2) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States internal revenue law.

In event of dissolution of this corporation, or in the event this corporation shall cease to exist the board of directors shall dispose of all of the assets of this corporation exclusively for the purposes of this corporation in the manner or to the organization or organizations that are organized and operated exclusively for charitable, educational religious or scientific purposes and that shall at the time qualify as exempt organizations under 501 (c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law, after paying or making provisions for the payment of all liabilities of this corporation. Any assets not so disposed of shall be disposed of by a court of competent jurisdiction in the county where the principal office of this corporation is then located exclusively for the purposes or to the organizations that the court determines are organized an operated exclusively for charitable, educational, religious or scientific purposes.

The corporation shall have three directors. Directors shall be appointed in accordance by the By-Laws.
