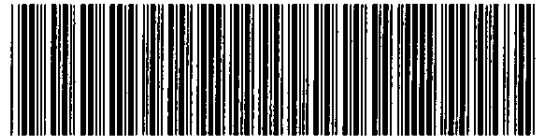

ARTICLES OF INCORPORATION  
In compliance with Chapter 720, F.S., (Homeowners Associations)

OF THE

SANIBEL LAND TRUST HOMEOWNERS ASSOCIATION, Inc.

In compliance with the requirements of Chapter 720, Section 720.301 through 720.313, Florida Statutes, the undersigned being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for purpose of organizing a Florida Homeowners' Association.

*Article I Name:* The name of the corporation shall be SANIBEL LAND TRUST HOMEOWNERS ASSOCIATION, INC. (the "Corporation").

*Article II Principal Office:* The principal place of business is 2401 Library Way, Sanibel, Lee County, FL 33957, the mailing address is 800 Dunlop Road, Lee County, Sanibel, FL 33957.

*Article III Purpose:* The purpose of the organization is to foster constituent input into the operations of affordable housing involving limited equity ownership on land trust land. Further it is to develop and enforce Codes, Covenants and Restrictions.

*Article IV Manner of Election:* Initially the Board of Directors shall be the subcommittee members of the declarant organization, Coast & Islands Community Land Trust, Inc. Subsequent elections shall take place for the Board of Directors seats with two directorships appointed by the Board of Directors of Coast & Islands Community Land Trust, Inc, one directorship appointed by the parent corporation Community Housing & Resources, Inc. at two directorships elected by the limited equity owners on an annual basis.

*Article VII Dissolution:* In the event of dissolution of the Corporation, The Board of Directors shall, after paying or making provisions for the payment of all liabilities of the Corporation, distribute all of the assets of the Corporation exclusively for purposes substantially similar to those of the Corporation to Coast & Island Community Land Trust, Inc., a Florida not for Profit Corporation.

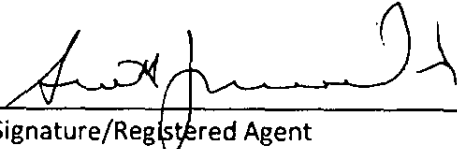
