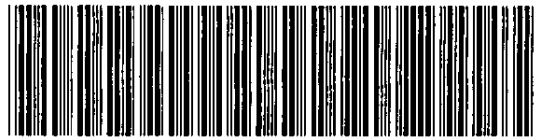

ARTICLES OF INCORPORATION
For HOUSE OF RESTORATION AND RECOVERY

The undersigned are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Florida, do hereby certify:

ARTICLE I NAME

The name of the corporation shall be:

HOUSE OF RESTORATION AND RECOVERY, INC.

ARTICLE II PRICIPAL OFFICE

The principal street address and mailing address is:

ARTICLE III PURPOSE

The purpose for which the organization is organized is:

Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. The corporation is to be established to aid, promote, encourage, and contribute to civic well being and humanity in general: primarily by promoting, supporting, and facilitating counseling and recovery programs, workshops, conferences, and other activities with the intent to further the recovery of persons from addictions, divorce, and disabilities and to improve the quality of their lives.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal

government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes, or to such organization or organizations, as said Court shall determine, which are organized and operated for such purposes.

ARTICLE IV MANNER OF ELECTION

The manner in which directors are elected or appointed:

The number of Directors of the House of Restoration and Recovery initial Board of Directors is fixed at four (4) and that the following named persons be and they are elected and designated to serve as the initial board members of the Board of Directors of House of Restoration and Recovery, to complete the organization of House of Restoration and Recovery and to serve in such capacity until May 31, 2011, and thereafter until their successors shall have duly elected and qualified as provided by the Bylaws of House of Restoration and Recovery:


