**ARTICLES OF INCORPORATION**  
**OF**  
**SILOAM KOREAN-AMERICAN CATHOLIC COMMUNITY, INC.**

In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I: NAME

The name of the corporation shall be **Siloam Korean-American Catholic Community, Inc.** hereafter referred to as SKACCI.

ARTICLE II: EFFECTIVE DATE

The effective date shall be August 15, 2009.

ARTICLE III: PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

ARTICLE IV: PURPOSE

The following are the purposes for which Siloam Korean-American Catholic Community, Inc. has established:

1. For the promotion of the Catholic religion, especially to those of Korean heritage by:
  - a. To promote greater understanding and strengthen our community through our shared faith and culture.
  - b. To enhance liturgical life and religious education of the community by inviting each member into full and active participation
  - c. Heightening awareness and fostering eagerness for the call of all Catholics to Evangelize

2. For charitable and religious purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

#### ARTICLE V: MANNER OF ELECTION

The manner in which the directors are elected:

1. The SKACCI Board of Directors will consist of six board members elected from and by the members.
2. The initial year, six directors will be elected from the existing Korean American Catholic Community (KACC) members to include the offices of President, Secretary, Treasurer, and three Directors.
3. There shall be a General Membership Meeting in February of each year, the date and time of the meeting to be announced 30 days in advance. There must be a quorum of 51% of members present during the meeting. During the meeting, the KACC members may endorse or replace the incumbent director or any officers with a popular vote of 51% of those present.
4. When any director / officer resigns, the KACC members shall elect a new director to fill the vacancy during a Special Membership Meeting which is announced 30 days in advance. The quorum and simple majority rules used in a General Membership Meeting will be in effect.
