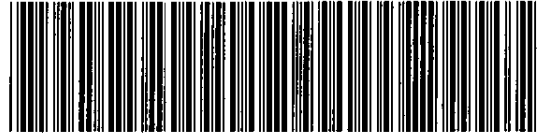

**ARTICLES OF INCORPORATION  
FOR  
MINISTERIO INTERNACIONAL EN SU PRESENCIA, INC.**

**ARTICLE I  
NAME**

The name of the Corporation is *Ministerio Internacional En Su Presencia, Inc.*

**ARTICLE II

**ARTICLE III  
COMMENCEMENT OF EXISTENCE**

The existence of the Corporation will commence on the date of the filing of these Articles of Incorporation.

**ARTICLE IV  
PURPOSE**

This corporation is organized exclusively for charitable, religious, missionary, educational, and scientific purposes including, for such purposes, the making of distribution to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue code, or the corresponding Section of any future federal tax code (the "Code"). Principally, this corporation is formed to establish and train a new generation for the Kingdom of God and spread the Gospel through preaching, conferences, and broadcasts via videos, television, internet and radio transmission, including the sales of books, musical cds and dvds, teaching cds and dvds, and works of art at conferences and over the internet.

**ARTICLE V  
BOARD OF DIRECTORS**

SECTION 1: The concerns, direction and management of the affairs of this corporation shall be vested in the Board of Directors. This corporation shall have no members.

SECTION 2: The Board shall at all times consist of at least three (3) directors, and may have such additional directors as provided in the Bylaws of the Corporation.

SECTION 3: The manner of electing directors shall be set forth in the Bylaws of the Corporation.

SECTION 4: The names, titles, and mailing address of the persons who shall serve as the initial directors of the Corporation are as follows:

#### **ARTICLE VI ACTIVITIES**

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to, its directors or officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article IV above. No substantial part of the activities of the Corporation shall be the carrying of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these Articles of Incorporation, the corporation shall not carry on any other activities not permitted to be carried on (i) by a corporation exempt from federal income tax under Section 502(c)(3) of the Code, or (ii) by a corporation, contributions by which are deductible under section 170(c)(2) of the Code.

#### **ARTICLE VII DISSOLUTION**

Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 502(c)(3) of the Code, or shall be distributed to

the federal government, or to a state or local government, for public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in

which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine which are organized and operated exclusively for such purposes.
