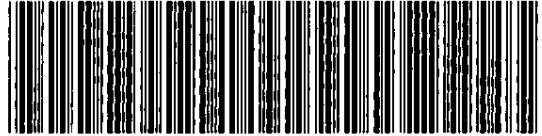

DOCUMENT OF INCORPORATION

ARTICLE I:

Florida Divinity University, Inc.

ARTICLE II:

2 South Texas Ave. Orlando, FL 32805

ARTICLE III:

A) Providing Christian and Evangelical education to all persons wishing to be better prepared in the knowledge of the Scriptures (The Bible) as the means to better serve God and their neighbors. Using it as a way to expand the Kingdom of Jesus Christ, either face to face, across the Internet and other means of communication available to both students and the institution of religious education.

B) The Florida Divinity University will organize teams of volunteer students, followers of Jesus Christ into the USA, and from United States of America to other countries of the world, to make disciples of Jesus Christ as a way to give the students the chance to take the training before graduation.

C) Both President and Vice-president are entitled to make any changes necessary for the good standing and according to the interest of the institution. The President is authorized to sign any contract to expand the university to anywhere in the world.

ARTICLE IV:

Every two years the board of directors will be elected, and every year the board of directors performance will be evaluated. It is required not less than 50% of the board of directors to be present in any meeting to elect and remove members at any time, the Board President must be present during any meeting where the Board of Directors is being evaluated.

- a) The President will be elected every two years.
- b) The Vice-president will be elected every two years.
- c) The Secretary will be elected every two years.
- d) The Treasurer will be elected every one year.
- e) The Vocal will be elected every one year.

Every one of them is to be elected by the 50% plus 1 of the members of the Board Directors.
