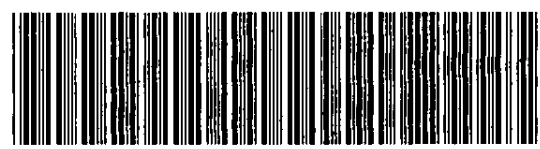

Amended wording to Article III:

Article III

This Foundation may engage in any activity or business permitted under the laws of the United States and the State of Florida. Said corporation is organized exclusively for charitable, educational and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

The purposes for which the Foundation is organized are as follows:

1. To operate as a corporation not-for-profit pursuant to the Florida Statutes.
2. To have and to exercise any and all powers, rights and privileges which a corporation organized under the not-for-profit corporation statutes of the State of Florida by law may now or hereafter have or exercise.
3. To promote the sport of sailing for the benefit of the young people of Indian River County, regardless of economic status, in an atmosphere which stresses safety, good sportsmanship, honesty, loyalty, courage, respect of authority, appreciation of the environment, and respect for the community.

This Article (Article IX) is to be added:

#### Article IX

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
